**TITLE**: FY 2017 – FY 2021 Community Investment Plan Prioritization Worksheet

Development of the FY 2017 – FY 2021 Community Investment Plan (CIP) is under way. Each year, a Prioritization Matrix Relative Weight Determination Worksheet is utilized for weighting the priorities of the Mayor and Commission as a factor for the staff review process for CIP projects. Staff is requesting that the worksheet be completed by the Mayor and each Commissioner on or before the March 1<sup>st</sup> Commission Conference Meeting. It is also included on the Conference Agenda for discussion, as necessary.

The proposed criteria are designed to promote a more informed decision-making process. The elements below will indicate and highlight the different benefits of a proposed community investment project. The decision matrix includes ten (10) program attributes which have been categorized and identified below:

#### Basic Program Attributes - Rank 1 to 5

- Federal, state and other legal requirements
- Project feasibility
- Costs and sources of funds
- Relevant performance measures
- Project consistency with existing plans

# <u>Impact on Strategic Goals/Cylinders of Excellence – Rank 1 to 5</u>

- Improves traffic, mobility, connectivity, pedestrian, cyclist safety
- Provides environmental benefits
- Addresses aging infrastructure needs and maintenance of existing facilities
- Promotes/accelerates sustainable economic development
- Improves neighbor safety

Each criterion contained in the attached worksheet requires ranking by level of importance on a scale of 1 (least important) to 5 (most important). Once all the rankings 3/01/2016

are received, staff will tabulate the individual responses and compute the average to determine the relative weight of each benefit criteria. This ranking process will assist in formulating recommendations to be presented to the City Commission.

The Mayor and Commission will be asked to read their rankings aloud at the Commission Conference Meeting.
