WALK ON - Motion to extend Medical Director services for the Fire-

Rescue Department provided by interim Benny Menendez, M.D.

Recommendation

It is recommended that the City Commission extend Medical Director services provided by Benny Menendez, M.D. who serves as interim Medical Director for \$ 4,903.10\$4108 per month and authorize Dr. Benny Menendez, M.D. to continue to provide Medical Director services for the Fire-Rescue Department for a period extended to April 6, 2016, or until further action by the City Commission, whichever is earlier.

Background

Due to the unfortunate and untimely death of Nabil El Sanadi, M.D. who provided Medical Director services, the City Commission approved Benny Menendez, M.D. to serve as Interim Medical Director for responsible medical and administrative oversight for the City's delivery of basic and advanced life support emergency medical services (CAM 16-0172). These services are provided by fire rescue paramedics and emergency medical technicians under the direction of a Florida licensed physician who is board certified in emergency medicine. The duration of this approval should be six months or until further action by the City Commission, whichever is earlier.

Pursuant to Section 1-172 (8) of the Code of Ordinances of the City of Fort Lauderdale, Florida, the Purchasing Division of the Code of Ordinances does not apply to professional medical services.

Resource Impact

There is a financial impact to the City in the amount of \$4,108.00 \$ 4,903.10 per month.
