Approval of a Contract with Retail Strategies Alabama, LLC for a Retail Feasibility Study, Strategic Planning and Business Recruitment within the Northwest Progresso Flagler Heights Community Redevelopment Area - \$50,000

Chair Seiler noted he had received emails on this CRA item from the CRA Advisory Board members and their feeling that it was rushed through. City Manager Feldman clarified this item is a completely different product and service noting this item builds on what has already been accomplished, the targeting of national tenants for the Northwest CRA. This company would do a feasibility study, the marketing, and will knock on doors to match up companies out there who would do well in this market and have been successful in other cities.

Commissioner Rogers noted the City was piggybacking on the City of Lake Worth's existing contract and felt the City needs to be more strategic and have a better contract. Commissioner Trantalis felt this item should go back to the CRA Advisory Board if they felt it was rushed through.

City Manager Feldman noted the vendor has a success fee model; however, the City's Procurement Code is not geared for that. Further discussions ensued on what the City needs to do to move forward. The Commission requested Retail Strategies Alabama, LLC come and give a presentation at their next meeting.

Commissioner Trantalis motioned to defer this item and was seconded by Commissioner Roberts.
