Jenni Morejon, Sustainable Development, addressed the Board on this item in lieu of Robert Jolly of Retail Strategies Alabama, LLC (Retail Strategies) because of a family matter. Ms. Morejon gave an overview of the contract with Retail Strategies and what they could offer to accomplish the goals of the Northwest Progresso Flagler Heights CRA.

Questions and discussions ensued from the Board members including the need to select a brand for the Northwest Progresso Flagler Heights CRA and subsequent followthrough with the marketing the brand. Discussions also included comments and evaluations on Mosaic's efforts in the Northwest Progresso Flagler Heights CRA and their possible interaction with Retail Strategies. City Manager Feldman explained the qualifications of Retail Strategies and what they can offer to reach intended goals for this specific geographic area of the City.
