CRA-2 15-0743 Motion Approving Redevelopment Incentive Funding for Rechter Holdings, Inc. in the Amount of \$206,267 for Project Located at 913 NE 4th Avenue

Discussions ensued among the Board members regarding the cost breakdown for funding this item. City Manager Feldman explained to the Board it was for the Rechter Holdings, Inc.'s project located at 913 NE4th Avenue. The breakdown consists of \$100,000 from the CRA Property and Business Investment Program, \$15,000 from the CRA Façade Program, and \$91,267 from the CRA Streetscape Grant Program.

The issue of parking at this location was raised and discussed among the board members. Michael Rechter of Rechter Holdings addressed the board and gave a brief overview of the parking situation and the parking study. Mr. Rechter also answered additional questions from the board on several aspects of the project and other items relating to this property
