CRA-2 16-0297 Proposed Amendments to the Fort Lauderdale Community Redevelopment Agency (CRA) By-Laws

Ray Cox addressed the Commission on the CRA By-Laws expressing his ideas, questions, concerns.

City Attorney Everett addressed the Commissioners questions regarding the proposed amendments to the CRA By-Laws. Commissioner Trantalis raised the issue of the challenges the Northwest CRA faces. Commissioner Trantalis felt the City Manager should not be the CRA Executive Director due to his many other responsibilities as City Manager and lack of sufficient time. Commissioner Trantalis noted the Executive Director position is one of being a visionary, and the Area Manager's role should be as implementers of the vision. City Manager Feldman stated he is fine with whatever structure the Commission decides for the CRA noting the intent was to give the Area Managers much more authority as CRA Director for the area.

Chair Seiler left the meeting for a phone call with the United States Secretary of the Navy. Prior to departing he noted he was in favor of the proposed amendments to the CRA By-Laws.

Commissioner Rogers explained why he felt City Manager Feldman should remain as the Executive Director of the CRA. Vice-Chair McKinzie noted his views on this subject and would like City Manager Feldman to remain as Executive Director of the CRA. Discussions and comments ensued on this topic among the Commission.

Jonathan Brown, Northwest CRA Area Manager, addressed the Commission noting his prior experience in economic development, business growth, and business retention in Palm Beach County.

Chair Seiler returned to the meeting at 5:07 p.m.

Charlie King addressed the Commission on this topic expressing his ideas, questions, concerns and recommendations including encouraging market rate housing in the Progresso area.
