ARCADIS-US, Inc. (ARCADIS), on behalf of Marathon Petroleum Company, LP (MPC), requests your stamp on this letter indicating your approval of the proposed above ground storage tank addition. This statement is requested by the City of Fort Lauderdale Zoning Department in accordance with Section 47-15 of the Unified Land Development Regulations (ULDR).

MPC owns and operates the Spangler Terminal (site) located at 909 SE 24th Street in Fort Lauderdale, Florida. The site is approximately 10 acres, and is equipped with several above ground storage tanks and load racks to store and transfer various petroleum fuel grades to tanker trucks for distribution to local service stations and other businesses. The storage tanks are located within a containment structure consisting of earth berms and concrete walls designed to meet Federal SPCC requirements. The site is zoned Port Everglades Development District (PEDD).

In order to meet increasing fuel demands within the Spangler Terminal's service area, MPC is proposing to increase the fuel storage capacity at the site with the addition of a new 160-foot diameter, 200,000 barrel capacity above ground steel storage tank intended to store blendgrade fuel (see attached drawings). The proposed project will also include a containment structure for the new tank and modifications of the existing stormwater management system.

The proposed storage tank will be located on private property adjacent to the other bulk storage tanks on the site, within the existing bermed containment area. The surrounding properties leased or owned by other petroleum companies are almost identical in use. The purpose of the tank is for bulk storage of petroleum products, which is consistent with other land use in Port Everglades. The Spangler Terminal currently stores approximately 11.5 million gallons of petroleum products. The


