TITLE: Approval and Acceptance of a Grant from Citizen Corps Grant through State of Florida Division of Emergency Management, FY2015 Citizen Corps Grant - \$5,720.00.

Recommendation

It is recommended that the City Commission approve a motion authorizing the City Manager to accept a grant from the State of Florida Division of Emergency Management and to execute any documents, including the attached contract in substantially the form attached, required to accept funds between the State of Florida Division of Emergency Management and the City of Fort Lauderdale.

Background

In August 2015 the Fire-Rescue Department applied, through the State of Florida Division of Emergency Management, for funding under the FY 2015 Citizen Corps Program. This grant program promotes partnership between local emergency service providers and the citizens they serve by training our neighbors in basic emergency preparedness, response and recovery skills and other preparation necessary to function as auxiliary personnel to first responders.

In October 2015, the State of Florida Division of Emergency Management awarded funds to the City in the amount of \$ 5,720.00. These funds will be used to pay for instructor and training expenses, and to purchase emergency equipment kits for CERT, Fire Explorers and Police Explorers participants. The program period for this grant is October 1, 2015 to September 30, 2016. There is no match requirement for this grant program.

Resource Impact

There is a positive fiscal impact to the City in the amount of \$5,720.00. Funds are being appropriated through companion item 16-0349.
