TITLE:	Motion to Approve Proprietary Purchase of Road Restoration Services – Community Asphalt Corp \$90,801.92

## **Recommendation**

It is recommended that the City Commission approve a proprietary purchase with Community Asphalt Corp. (Community Asphalt) for restoration due to construction of small water main improvements on Sunrise Boulevard in the amount of \$90,801.92.

## **Background**

On January 20, 2016, the City Commission approved Commission Agenda Memo (CAM) #16-0099 for the Small Water Main Improvement Project in Lake Ridge on Sunrise Boulevard between Sunrise Boulevard and Federal Highway. This project involves the replacement of 4,000 linear feet of existing undersized water mains on Sunrise Boulevard between Flagler Drive and Federal Highway following several water main breaks due to deteriorated water pipes.

Restoration of pavement and placement of permanent pavement markings on Sunrise Boulevard following the water main work was to be completed as part of the Florida Department of Transportation (FDOT) US-1 project scheduled for completion in April 2016, also being done by Community Asphalt. Due to scheduling issues, it has been determined the best way to complete both projects is to include restoration of pavement and the placement of permanent pavement markings of the westbound, outside lane of SR 5/US-1 (Sunrise Boulevard) into the City's project. Staff has requested acceptance of FDOT funding for this work through a Joint Participation Agreement (CAM #16-0385).

This purchase is to complete milling and resurfacing, friction course, and placement of permanent pavement markings to restore Sunrise Boulevard following completion of utility work.

Pursuant to Section 2-189, Code of Ordinances of the City of Fort Lauderdale, Florida, the City may purchase proprietary items, as defined in Section 2-173, without the necessity of public bids. As defined by the Code, proprietary means any item or service essential to the day-to-day operation of the city government and when time is of the essence. Proprietary may also apply when material and services are not readily subject

to competition or whereby specifications cannot clearly be drawn or when time is of the essence. Time is of the essence for this purchase due to the FDOT contractor being mobilized and currently performing the work for FDOT, as well as the approved Modification of Traffic.

## Resource Impact

There will be a fiscal impact to the City in the amount of \$90,801.92 for construction; however, it will be offset by the grant contingent upon approval and appropriation at the April 5, 2016 Commission Meeting (CAM #16-0349).
