**LETTER OF COLLABORATION BETWEEN THE CITY OF FORT LAUDERDALE, FL  
RESULTS FOR AMERICA, JOHNS HOPKINS UNIVERSITY  
AND THE SUNLIGHT FOUNDATION**

This *Letter of Collaboration* (LOC) is entered into by and between the city of Fort Lauderdale, FL ("Fort Lauderdale" or "the City") having a location at 100 N. Andrews Avenue, Fort Lauderdale, FL 33301 for a project designed to accelerate the use of data and evidence to improve the lives of its residents. In addition to the City of Fort Lauderdale, the partners include Results for America ("RFA"), having a location at 1460 Broadway, New York, NY 10036, Johns Hopkins University, a not for profit educational institution established under the laws of the State of Maryland having a location at 3400 N. Charles Street, Baltimore, MD 21218-2685 on behalf of Johns Hopkins University Center for Government Excellence (GovEx) and The Sunlight Foundation ("Sunlight") have a location at 1818 N St. NW, Washington, DC 20036; hereafter referenced to as What Works Cities ("WWC or WWC Team"). The study is funded under prime award sponsored by The Bloomberg Family Foundation, Inc. which established the "What Works Cities initiatives. This LOC contains the scope of work for the project, the timeline, and the responsibilities of the various partners that will contribute to its success.

**1. Summary of the Work Plan**

1.1 Mayor John P. "Jack" Seiler, City Manager Lee R. Feldman and the senior leadership team of the City of Fort Lauderdale have crafted an ambitious agenda for Fort Lauderdale that includes achieving the aspirational *Fast Forward Fort Lauderdale* Vision Plan, through *Press Play Strategic Plan* goals such as, connectivity and mobility, resilient infrastructure, sustainability, neighborhoods, economic development, and public safety, and innovation. The WWC team, having reviewed Fort Lauderdale's WWC statement of interest and self-assessment, and having conducted an on-site workshop with Mayor Seiler, City Manager Feldman, and their staff, have identified an opportunity for which WWC can assist Fort Lauderdale in advancing its goals:

- **Open Data (Partners: GovEx and Sunlight):** Fort Lauderdale will leverage open data and data governance, in concert with existing performance management practices (i.e. FL<sup>2</sup>STAT & Department Scorecards), to drive measurable progress on its Fast Forward Fort Lauderdale 2035 Vision. In the process, Fort Lauderdale will codify and standardize open data processes and policies to share data openly with residents, as well as internally, while ensuring staff across city departments are knowledgeable on the purpose of data collection, regularly collect and publish data, and make decisions based on such data.

- **Analytics (Partner: GovEx):** Fort Lauderdale will expand their internal analytic team capabilities for generating data-driven solutions that will efficiently and effectively allocate public resources.

All technical assistance described in this LOC and performed by WWC partners is provided at no cost to Fort Lauderdale. Additional scopes of work may be added to this LOC at a later date upon the written agreement of the parties.

## **2. Working Together**

2.1 WWC consists of world-class practitioners and experts who will work with participating cities to deepen their use of data and evidence to improve residents' lives. Fort Lauderdale's open data scope of work will be supported by the Center for Government Excellence (GovEx) and the Sunlight Foundation (Sunlight). In addition, Fort Lauderdale's liaison from Results for America, Molly Daniell, will ensure that Fort Lauderdale receives clear communication from all WWC partners and that the City has access to the WWC learning network. This network includes opportunities to share experiences and learn from and with city government peers.

2.2 To ensure that the time of all parties is used efficiently with respect to the activities listed in this LOC, partners will collaborate with Fort Lauderdale via phone, video conference, and email, and on site where appropriate. Fort Lauderdale agrees to provide personnel and staff time, as further detailed on page 3 and page 5, and as determined necessary in consultation with RFA, GovEx and Sunlight. Fort Lauderdale also agrees to designate a primary point of contact to provide partnership coordination on behalf of the City.

## **3. What Works Cities Partner Descriptions**

3.1 Johns Hopkins University's new Center for Government Excellence (GovEx) helps governments build capacity for decision making that is rooted in evidence, transparent accountability, and citizen engagement. The center is part of the University's 21st Century Cities Initiative, a cross-disciplinary research effort for urban study and change. The new center educates governments about best practices for the collection, measurement, and analysis of data, helping them to better assess job functions, improve service delivery, decrease waste, and engender public trust.

3.2 Results for America is a national non-profit that strives to improve outcomes for young people, their families, and communities by shifting public resources toward practices, policies, and programs that use evidence and data to improve quality and get better results. Beyond scaling individual programs, Results for America seeks to drive broader systems-change so that "investing in what works" becomes the new norm for allocating public dollars. As the campaign managers behind What Works Cities, Results for America will ensure a world-class experience for all What Works cities and advance a nationwide dialogue on the need to invest in what works.

3.3 The Sunlight Foundation is a national, nonpartisan, nonprofit organization that uses the tools of civic tech, open data, policy analysis and journalism to make government and politics more accountable and transparent to all. Sunlight's vision is to use technology to enable more complete, equitable and effective democratic participation. The Sunlight Foundation actively monitors and supports existing open data initiatives, provides research, supports best practices and offers support for new policy development. And, while Sunlight's work began in 2006 with a focus on the U.S. Congress, its open government work now takes place at the local, state, federal and international levels. Individual staff biographies are in listed in the Appendix.

#### **4. Next Steps**

The next steps are to finalize work plans and sign this LOC, thus agreeing on the terms and activities outlined within. The due dates for these next steps are shown in the chart below:

After these steps are complete, the engagement will begin. The scope of work for the Open Data engagement is as follows:

#### **5 Scope of Work: Open Data**

On March 1, the City, Sunlight, and GovEx will begin the Open Data project and terminate as defined in the under Activities of the partners.

##### **5.1 Partners: Fort Lauderdale, Sunlight Foundation, and GovEx**

**Goal:** Fort Lauderdale will leverage open data and data governance, in concert with existing performance management practices (i.e. FL<sup>2</sup>STAT & Department Scorecards), to drive measurable progress on its Fast Forward Fort Lauderdale 2035 Vision. In the process, Fort Lauderdale will codify and

standardize open data processes and policies to share data openly with residents, as well as internally, while ensuring staff across city departments are knowledgeable on the purpose of data collection, regularly collect and publish data, and make decisions based on such data.

**Outcomes:** In order to achieve this goal, Sunlight and GovEx will help Fort Lauderdale:

- Develop a formal, comprehensive open data policy while codifying collection and publication processes;
- Make data available to employees and the public in a more useful and responsive way; and
- Link open and transparent data to the city's performance analytics programs to ensure data informs decisions that drive progress toward Fast Forward Fort Lauderdale (FFFL 2035).

**Activities:** Starting within fourteen days after this agreement is signed and concluding approximately 90 days thereafter, Fort Lauderdale will work with Sunlight and GovEx on a range of activities that will institute practices and a culture of open data, including:

**Within 30 days after engagement begins, Fort Lauderdale will:**

- Conduct an assessment of Fort Lauderdale's existing data and performance analytics environment, including summarizing existing data collections processes and workflows, and providing copies of any relevant existing policies;
- Define open data goals and dataset priorities, including a list of proposed partners and stakeholders;
- Introduce and validate the concept of open data to relevant internal stakeholders; and
- Create an opportunity to publicly state Fort Lauderdale's commitment to meeting strategic goals through open data.

**Within 60 days after engagement begins, Fort Lauderdale will:**

- Create open data policy using model policy language from Sunlight and example policies from other cities as guidance;
- Develop a draft data governance plan for Fort Lauderdale, including committee governance and membership, key outcome indicators, and draft meeting agendas and schedules;
- Create an initial inventory of the City's datasets, which are available for public release with a special focus on FL<sup>2</sup>STAT key performance indicators and metrics;
- Review datasets to be opened that integrate into the performance analytics process; and
- Introduce the concept of open data portals and public-facing performance analytics dashboards, and initiate a discussion/analysis of open data portal solutions with internal stakeholders.

**Within 90 days after engagement begins, Fort Lauderdale will:**

- Enact open data policy for Fort Lauderdale;
- Convene the initial data governance committee meeting;

- Engage the governance committee in key foundational decisions designed to facilitate the release of data to members of the FL<sup>2</sup>STAT team and ensure that Ft. Lauderdale's open data practices are sustainable;
- Establish a plan to share open data updates and outcomes with the public; and
- Begin incorporating external stakeholders and the public at large in the open data process.

**Within 120 days after engagement begins, Fort Lauderdale will:**

- Building upon the work of the open data governance committee, engage the FL<sup>2</sup>STAT team to work with departments to refine its metrics and targets and ensure alignment between FL<sup>2</sup>STAT, Department Scorecards, and the Fast Forward Fort Lauderdale 2035 Vision Scorecards.

5.2 Fort Lauderdale, with support from the Center for Government Excellence and the Sunlight Foundation, is responsible for the success of the Open Data project. Fort Lauderdale will dedicate the personnel and staff time, determined necessary in consultation with GovEx and Sunlight, to execute the activities outlined in this scope of work. Staff will include those project managers, developers, and analysts responsible for overseeing the City's open data program. Success will also require support and participation from agency heads or their designees, municipal data owners, technologists and developers, project managers, and parties responsible for developing management policy on behalf of the Mayor.

5.3 In order to facilitate and execute these activities, the Center for Government Excellence and Sunlight Foundation will provide Fort Lauderdale with technical assistance, resources, and tools. Fort Lauderdale should expect to receive expert, proactive support from the Center for Government Excellence and Sunlight Foundation team, working both on-site and remotely. GovEx and Sunlight staff will provide guidance with drafting executive orders and legislation by providing sample and model language, as well as offering resources and best practices. In addition, GovEx and Sunlight will offer coaching on implementation roadblocks and support connections with other Open Data practitioners.

5.3 To plan staff time for this initiative, consider that services may include weekly calls 30 minutes in length, access to 60-minute open data curriculum sessions, and webinars and facilitated meetings as agreed upon by the Fort Lauderdale, GovEx, and Sunlight.

#### **6. Scope of Work: Data Analytics**

On March 1, the City and GovEx will begin the Data Analytics project and terminate as defined in the under Activities of the partners.

**Goal:** With GovEx assistance and support from Mike Flowers, Fort Lauderdale will launch projects that will provide genuine improvements in government service delivery via data analytics, as well as lay a foundation for a politically resilient data and evidence driven decision support infrastructure.

**Outcomes:** In order to achieve this goal, GovEx will help Fort Lauderdale:

- Identify and launch specific service delivery optimization projects appropriate for analytics-driven intervention, and monitor progress of the projects over time
- Socialize and expand the analytical unit's capabilities to oversee and support data-driven decision making capacity
- Align analytics and open data/performance management efforts as set forth in Fast Forward Fort Lauderdale 2035

**Activities:** Starting within fourteen days after this agreement is signed and concluding approximately 120 days thereafter, Fort Lauderdale will work with GovEx on a range of activities that will lay groundwork for the desired outcomes, including:

**Within 60 days after engagement begins, Fort Lauderdale and GovEx will:**

- Conduct an on-site assessment of Ft. Lauderdale's current analytics capabilities through an on-site visit, focusing on the city's needs and identifying potential projects;
- Identify service delivery challenges that it wishes to optimize via analytics, including summarizing existing data, and providing copies of any relevant existing policies;
- Identify and ensure cooperation with critical stakeholders, including but not limited to: Executive leadership, CIO or analogous agency, agencies receiving optimization assistance, and City attorney; and
- Introduce and validate the concept of city analytics to relevant internal stakeholders.

**Within 90 days after engagement begins, Fort Lauderdale will:**

- Complete analysis of data relevant to service delivery challenges selected by City;
- Complete analysis of service delivery logistics chain to identify appropriate method of surfacing analytics insight product into operations; and
- Ensure cooperation of participating agency stakeholders in implementation of pilot project(s) via continuous communication.

**Within 120 days after engagement begins, Fort Lauderdale will:**

- Launch analytics pilot project, testing and iterating on the project for the next 60 days;
- Assess results of the pilot and modify where appropriate; and
- Identify strategy for institutionalization of capacity at enterprise level.

**6.2** Fort Lauderdale, with support from the Center for Government Excellence, is responsible for the success of the Open Data project. Fort Lauderdale will dedicate the personnel and staff time, determined necessary in consultation with GovEx, to execute the activities outlined in this scope of work. Staff will include those project managers, developers, and analysts responsible for overseeing the City's analytics practice. Success will also require support and participation from agency heads or their designees, municipal data owners, technologists and developers, project managers, and parties responsible for developing management policy on behalf of the Mayor.

6.3 In order to facilitate and execute these activities, the Center for Government Excellence will provide Fort Lauderdale with technical assistance, resources, and tools. Fort Lauderdale should expect to receive expert, proactive support from the Center for Government Excellence team, working both on-site and remotely. GovEx staff will provide guidance on how Ft. Lauderdale should develop its internal analytical capabilities, and then assist those teams with devising and implementing data-driven solutions that effectively allocates resources. In addition, GovEx will offer coaching on implementation roadblocks and support connections with other analytics practitioners.

6.4 To plan staff time for this initiative, consider that services may include weekly calls 30 minutes in length, on-site engagement work, access to 60-minute analytics curriculum sessions, and webinars and facilitated meetings, as agreed upon by the Fort Lauderdale and GovEx.

## **7. Confidentiality and Privacy**

7.1 All parties to this LOC will agree to protect clearly marked Confidential Information of one another in a reasonable and appropriate manner, and will use confidential information only to perform its obligations under this engagement and for no other purpose. This will not apply to information which is publicly known, already known to the recipient, lawfully disclosed by a third party, independently developed, disclosed pursuant to legal requirement or order, and items that are subject to public records access laws.

7.2 WWC partners agree to use any personally identifiable information and data the City provides them only for the purposes of this engagement and as the City directs, and WWC partners will not be liable for any third-party claims related to such Fort Lauderdale agrees to take necessary actions to ensure that the City complies with applicable laws relating to privacy and/or data protection, and acknowledge that WWC partners are not providing legal advice on compliance with the privacy and/or data protection laws of any country or jurisdiction.

## **8. Publicity and Use of Names**

8.1 WWC will work together with the City to pursue opportunities that highlight and celebrate the successes of Fort Lauderdale and its city leaders in the media. RFA will lead this coordinated media effort along with those in the City's communications office.

8.2 The City agrees to acknowledge Bloomberg Philanthropies, WWC and the associated partners in publications, advertising, speeches, lectures, interviews, press releases, internet web pages, and other similar activities related to the LOC (together, "Media Releases"). Any Media Release that refers to WWC, RFA, GovEx, Sunlight and/or Bloomberg Philanthropies, and all written acknowledgements shall link to the WWC website ([www.whatworkscities.org](http://www.whatworkscities.org)). The City shall provide copies of all Media Releases to RFA and the relevant WWC partner and obtain those parties' consent prior to publication or distribution in any format of any Media Release. Further, to the extent that the City provides Media

Releases to WWC, the City represents that it owns or otherwise has obtained all rights necessary to use, reproduce, publicly perform and distribute (including the right to sublicense) all works contained or used in the Media Releases. All requests for Johns Hopkins University approval shall be forwarded to the individual list under the section entitled "Notices.

#### **9 Intellectual Property**

WWC agrees that all trademarked or copyrighted works owned by the City (including but not limited to logos, written material, photos, and other similar works provided by the City to WWC) and provided to WWC, in any media, shall remain the property of the City. To the extent that the City provides any Media Release (and works contained therein) or trademarked or copyrighted works to WWC, the City represents that it owns or otherwise has obtained all rights necessary to use, reproduce, publicly perform and distribute (including the right to sublicense) all such works. WWC has the right to publicly acknowledge and announce, at its sole discretion, any relationship between WWC and the City, including a description of activities undertaken in this LOC and learnings therefrom.

#### **10 Liability and Indemnification**

#### **11 Termination of Work**

Adherence by the City to timelines and deliverables is critical to the What Works Cities Initiative. If either party is unable to comply with the timeline in this LOC or is unable to produce the deliverables described herein, before termination may be effective, the terminating party must provide a thirty – (30) days prior written notification to the other party, the LOC may be terminated effective immediately upon written notice served to the other party.






