AMENDMENT TO AGREEMENT FOR INDUSTRIAL PAINTING SERVICES

THIS AMENDMENT TO AGREEMENT, made this day of poil 2016, by and between the City of Fort Lauderdale, a Florida municipality, ("City"), whose address is 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016, and J & J, Inc., a Florida corporation d/b/a Eagle Painting, ("Contractor" or "Company") whose address and phone number are 10062 NW 50th Street, Sunrise, Florida 33351, Phone: 954-746-7300, Email: janet@eaglepaintingfla.com.

WHEREAS, the City and Contractor entered into an Agreement for Industrial Painting Services pursuant to Invitation to Bid 453-11613 (ITB) dated November 3, 2015 ("Agreement"); and

WHEREAS, the Agreement provided for a maximum amount payable to the Contractor of \$93,000 for a two-year term; and

WHEREAS, the City and Contractor also wish to amend the Agreement by adding additional locations to be painted for the Parks and Recreation Department constituting a maximum number of 1600 hours plus materials or \$60,000;

NOW THEREFORE, for and in consideration of the mutual promises and covenants set forth herein and other good and valuable consideration, the City and the Contractor agree to amend the Agreement as follows:

- 1. Section III of the Agreement is hereby amended to add the following: The City reserves the right to extend the contract for three additional one-year terms, providing all terms conditions and specifications remain the same, both parties agree to the extension, and such extension is approved by the City.
- 2. Increasing scope of service to include additional locations for the Parks and Recreation Department constituting a maximum number of 1600 hours plus materials or \$60,000.
- 3. All other terms and provisions of the original Agreement between the parties shall remain in full force and effect.
