- Agrees to the entrance on A1A NB from Oceanside.
- 5th Street should be 2-way.
- Concerned over what has been spent, believes it is more than 5.5 million.
- <u>AD noted that parking garages do not generate traffic, it is the associated land uses</u> around it.
- Current feasibility study notes that there are several hotel and condo projects are currently included in the study, and it is not accurate, does not believe the Bahia mar is included in the study.
- <u>AD noted</u> that the study update is in the works, reviewing the worst case scenario
- <u>PK noted</u> that the City keeps track of the number of trips for projects that have been submitted into the City, which has a maximum cap in the Regional Activity Center (RAC). There are still trips available within the RAC.
- Believes that trip counts are ordered by the developer.
- Do a true traffic count in January or February, not in June and then adjust.
- Live in the Venetian and cars wait for 15-20 minutes even now.
- Don't give a concession to Bahia Mar to go higher without a concession from them for additional parking.
