<u>SECTION 5</u>. That Section 20-83, Code of Ordinances of the City of Fort Lauderdale, Florida, is amended to provide as follows:

The following professional managerial and administrative employees in the office of the city manager are administrative assistants to the city manager: administrative assistant, administrative assistant I, administrative assistant II, assistant to the city manager, senior assistant to the city manager, structural innovation manager, budget manager, public affairs manager, neighbor services support manager, assistant budget manager, assistant manager of CIP (Community Investment Plan)/Grants, financial management analyst, senior financial management analyst, principal financial analyst, performance analyst, senior performance analyst, chief service officer, assistant neighbor support manager, assistant structural innovation manager, assistant public affairs manager, professional standards manager, and management analyst.

<u>SECTION 7</u>. That if any clause, section, or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.
