Please take notice that on Tuesday, June 7, 2016 at 2:30 P.M. or as soon thereafter as possible, in the City Commission Conference Room, 8th Floor, City Hall, 100 North Andrews Avenue, Fort Lauderdale, Florida, the following item will be heard by the Fort Lauderdale Community Redevelopment Agency ("CRA"): AN AGREEMENT TO PROVIDE A STREETSCAPE GRANT TO STEVEN B. GREENFIELD, AS TRUSTEE, FOR THE FLAGLER VILLAGE LAND TRUST FOR THE QUANTUM AT FLAGLER VILLAGE PROJECT, A MIXED-USE DEVELOPMENT LOCATED IN THE FLAGLER VILLAGE AREA OF THE NORTHEAST-PROGRESSO-FLAGLER HEIGHTS COMMUNITY REDEVELOPMENT

The Community Redevelopment Agency Board of Directors agrees to provide a grant, if approved, for streetscape improvements for a total amount not to exceed \$500,000. The \$500,000 is approximately 28% of the total cost of improvements which is estimated to be \$1,768,980. The public improvements include the installation of new cubing, pavers, sidewalks, on-street parking, landscaping, lighting, undergrounding and upgrading utilities and street resurfacing. Pursuant to Section 255.20(1)(c)10, Florida Statutes (2015), the Fort Lauderdale Community Redevelopment Agency (CRA) will consider whether it is in the public's best interest to fund the improvements installed using the criteria and procedures permitted under the City of Fort Lauderdale Code of Ordinances, Section 2-189, to the Developer's contractor performing the on-site (non-publicimprovements) instead of requiring the Developer to use a competitive selection process to complete the portion of the Project involving the construction of public improvements.

All interested parties may appear at said meeting and be heard with respect to the proposed action
