**TITLE:** Motion to Approve Purchase of After School Snack Program – Resto  
Concepts Inc. d/b/a 2Taste Catering - \$66,096

---

**Recommendation**

It is recommended that the City Commission approve a one-year contract, in substantially the form attached, with Resto Concepts Inc. d/b/a 2Taste Catering for the purchase of after school snacks in the estimated amount of \$66,096; and authorize the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds. Any purchases made under the contract will be contingent upon award and acceptance of the Afterschool Meals Program Grant by the City for that year.

**Background**

The City of Fort Lauderdale Parks & Recreation Department has seven licensed after school sites through Broward County. Agencies with licensed after school programs are eligible to participate in the Child Care Food Program funded by the Florida Department of Health. This program is administered similar to the Summer Food Service Program. Vendors providing the meals for this program must be on a state-approved list issued by the Florida Health Department.

This grant will allow the Parks and Recreation Department to purchase and serve snacks daily to children in our seven after school park locations. The cost of each snack is \$1.02 with \$0.84 being reimbursed by the state. The estimated total cost to provide snacks is \$66,096; we will be reimbursed a projected amount of \$53,642.

The Procurement Services Division issued Invitation to Bid No. 562-11762 and received four bids. The bid submitted by Resto Concepts Inc. d/b/a 2Taste Catering has met all of the specifications of the bid and has been deemed the lowest cost, responsive and responsible bidder.

### **Resource Impact**

There will be a fiscal impact to the City in the estimated amount of \$12,454. The grant expenses are contingent upon the acceptance and approval of the Afterschool Meals Program Grant. The grant application process is currently taking place.
