TITLE: Motion to Approve Execution of a Fifth Amendment to the Revocable License
with B-cycle, LLC

Recommendation

It is recommended that the City Commission approve execution of a Fifth Amendment to the B-cycle Revocable License granted to B-cycle, LLC to expand the existing South Beach Lot #2 bike-share station, subject to the conditions listed below.

Background

On July 6, 2011, the City Commission approved a Revocable License with B-Cycle, LLC, subject to Chapter 27, Article IV, of the Code of Ordinances of the City of Fort Lauderdale (Code), to allow bike-sharing stations on City-owned property.

On November 10, 2015, the Development Review Committee (DRC) reviewed B-cycle LLC's application for the expansion of the South Beach Lot # 2 bike-sharing station and found the station in compliance with the criteria regarding location of bicycle sharing stations as provided in Chapter 27, Article IV of the Code. At the DRC meeting the applicant stated that the bikes will be removed for special events.

In accordance with the proposed Fifth Amendment to the Revocable License (Exhibit 1), B-Cycle LLC is requesting to expand the South Beach Lot #2. The site plan and location map for the station expansion are attached as Exhibit 2.

Staff recommends that approval be conditioned on the following:

- All bikes shall be removed from station during special outdoor events in the area. Special outdoor events refer to every event approved by the City Commission for the area where the bike station is located which is considered the Fort Lauderdale Beach Park area. Special outdoor events shall also include events approved by the Director of

- Parks and Recreation or his/her designee. Such events include but are not limited to:
- a. Outdoor concerts
 - b. Athletic events
 - c. Events that are approved by the City Commission
 - d. The events where the bikes will affect foot traffic and loading includes, but are not limited to:
 - i. Fort Lauderdale Boat Show
 - ii. Tortuga Music Festival
 - iii. Swatch Volleyball Tournament
 - iv. Rip Tide Music Festival

Resource Impact

There is no fiscal impact associated with this action.

Strategic Connections

This item is a *Press Play Fort Lauderdale Strategic Plan 2018* initiative, included within the Infrastructure Cylinder of Excellence, specifically advancing:

- Goal 1: Be a pedestrian friendly, multi-modal City.
- Objective 2: Integrate transportation land use and planning to create a walkable and bikeable community.
- Initiative 4: Develop bike amenities.

This item advances the *Fast Forward Fort Lauderdale Vision Plan 2035: We Are Connected*.
