

RESOLUTION NO. 16-89

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION NO. 16-60 APPOINTING THE LAW FIRM OF GREENBERG TRAURIG, P.A., TO ACT AS BOND COUNSEL, AND LAW OFFICES OF STEVE E. BULLOCK, P.A. TO ACT AS DISCLOSURE COUNSEL TO THE CITY OF FORT LAUDERDALE, FLORIDA IN CONNECTION WITH ISSUANCE OF WATER AND SEWER REVENUE AND REVENUE REFUNDING BONDS, SERIES 2016.

WHEREAS, pursuant to Resolution No. 16-60 the City Commission appointed Albert del Castillo, Esq., of Greenberg Traurig as bond counsel to the City of Fort Lauderdale in connection with the aforementioned bond issue, subject to certain terms and conditions; and

WHEREAS, pursuant to Resolution No. 16-60 the City Commission appointed Steve E. Bullock, Esq. of the Law Offices of Steve E. Bullock, P.A., as disclosure counsel in connection with the aforementioned bond issue, subject to certain terms and conditions; and

WHEREAS, the amendment of Resolution No. 16-60 corrects a scrivener's error regarding compensation of Disclosure Counsel;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That Albert del Castillo, Esq., of the law firm of Greenberg Traurig, P.A., pursuant to Resolution No. 16-60, was appointed as bond counsel for the City of Fort Lauderdale in connection with the issuance of bonds as described herein.

SECTION 2. That Steve E. Bullock of the Law Offices of Steve E. Bullock, P.A. pursuant to Resolution No. 16-60, was appointed as disclosure counsel in connection with the issuance of the bonds as described herein.

SECTION 3. That if the bonds are sold, Albert del Castillo of the law firm of Greenberg Traurig, P.A. shall be paid a fee of \$1.10 per \$1,000 of bonds issued, plus expenses in an amount not to exceed \$2,500 for services as bond counsel.

SECTION 4. That if the bonds are sold, Steve E. Bullock of the Law Offices of Steve E. Bullock, P.A., shall be paid a fee of \$0.88 per \$1,000 of bonds issued, plus expenses in an amount not to exceed \$2,000 for services as disclosure counsel.

SECTION 5. That such bond counsel and disclosure counsel hereby appointed shall serve at the pleasure of the City Commission of the City of Fort Lauderdale, Florida.

SECTION 6. That the proper City Officials are authorized to execute such agreements as are necessary with the law firms selected in accordance with the provisions of this Resolution.

SECTION 7. That this Resolution shall take effect immediately upon its adoption.
