TITLE: Motion to Approve Purchase of Horticultural Chemicals – Various Vendors

- \$86,000

Recommendation

It is recommended that the City Commission award two-year contracts for the purchase of horticultural chemicals through the Southeast Florida Governmental Cooperative Purchasing Group (Co-op) Contract/Bid No. B-16-66 from the vendors listed below in the aggregate amount of \$86,000.

Background

This procurement is through a Southeast Florida Governmental Cooperative Purchasing Group (Co-op) contract, with the Town of Davie acting as lead agency. The City of Fort Lauderdale, along with twenty other municipalities, utilizes this contract. The commodities contained in the bid were determined by participating agency members consisting of products used by the majority of the Co-op.

The awarded vendors will supply horticultural chemicals for all Parks and Recreation Department maintained areas. This includes all athletic fields and parks, the beach, medians, entranceways, fire stations, City-owned office buildings and open space areas.

The vendors listed below are the lowest responsive and responsible bidders awarded for items in accordance with unit prices identified in Exhibit 1:

Helena Chemical Company, Dade City, FL SiteOne Landscape Supply, LLC, Dania Beach, FL Diamond R. Fertilizer Co., Inc., Fort Pierce, FL Howard Fertilizer & Chemical Company, Inc., Orlando, FL

Pursuant to Section 2-198, Code of Ordinances of the City of Fort Lauderdale, Florida, the city manager or the city manager's designee shall have the authority to join with other units of government in cooperative purchasing plans when the best interest of the city would be served thereby.

Resource Impact

There will be a fiscal impact to the City in the estimated amount of \$10,800 in FY 2016. Future expenditures are contingent upon approval and appropriation of the annual budget.
