TITLE:	Resolution Authorizing the Acceptance of Grant Funds and Execution of a Grant Agreement with Federal Aviation Administration for the Design of Taxiway Foxtrot Pavement Rehabilitation at Fort Lauderdale Executive Airport

#### **Recommendation**

It is recommended that the City Commission adopt a resolution accepting grant funding of \$227,557 or 90% of the costs, whichever is less, for the design of Taxiway Foxtrot Pavement Rehabilitation at Fort Lauderdale Executive Airport (FXE) from the Federal Aviation Administration (FAA) and authorize the City Manager to execute a Grant Agreement, contingent upon review and approval by the City Attorney, on behalf of the City for such funding.

#### Background

As part of the ongoing Statewide Airfield Pavement Management Program, the Florida Department of Transportation (FDOT) performed a review of FXE's pavements and issued a report with its findings in June 2015. The review determined that Taxiway Foxtrot's Pavement Condition Index (PCI) had a value of 59. The FDOT recommends a minimum service level PCI of 65 for parallel taxiways. The minimum service level is recommended to ensure the pavement provides a safe operational surface and efficiently uses maintenance and rehabilitation budgets. In addition, the geometry of taxiway intersections along Taxiway Foxtrot is non-compliant with the current FAA design standards and will be addressed during this project.

A task order has been developed to address the above issues. The task order will consist of conducting airport staff review meetings, preparing construction plans, construction phasing schedule, surveying, electrical design, geotechnical testing, disadvantage business enterprise (DBE) support services, preparing construction cost estimates, bid specifications, and assistance during the bidding process.

In an effort to not delay the project, the FAA indicated that the Airport may proceed to award the task order pending award of the grant. The initial amount anticipated from the FAA was \$314,727 and a budget amendment was completed to appropriate the funds at the May 3, 2016 City Commission meeting.

However, the scope of the project was revised and the anticipated amount from the FAA changed to \$227,557. A budget amendment will be completed to reduce the appropriation to \$227,557 after the grant is awarded.

The estimated project cost for design of the project is \$252,841, which will be partially funded by a grant from the FAA for approximately 90% (\$227,557) of the anticipated design costs. The FDOT has executed a joint participation agreement in the amount of \$17,500 to provide up to 5% of the design costs. FXE's matching share of \$17,500 (5%) is provided for in the project fund.

# Resource Impact

There is a positive fiscal impact to the City for the grant in the amount of \$227,557 which was appropriated via the May 3, 2016 Consolidated Budget Amendment CAM #16-0466. The required grant match of \$17,500 is currently funded in the Community Investment Plan.

This item was reviewed and approved by the Aviation Advisory Board at its meeting on April 28, 2016.
