#### PRODUCT EVALUATION AGREEMENT

THIS PRODUCT EVALUATION AGREEMENT ("Agreement") dated this 2nd day of May, 2016, (the "Effective Date") is made and entered into by and between Cellebrite Inc., a Delaware corporation, 7 Campus Drive, Suite 210, Parsippany, NJ 07051, ("Cellebrite"), and City of Fort Lauderdale, 1300 W. Broward Boulevard, Fort Lauderdale, Florida 33312, ("Evaluator").

WHEREAS, Cellebrite is a leading provider of mobile forensic and data transfer solutions, including associated software and documentation ("Products"), which Cellebrite is willing to provide to Evaluator on the terms and conditions set forth herein; and

WHEREAS. Evaluator desires to evaluate the Products solely for its internal purposes;

NOW, THEREFORE, in consideration of the mutual agreements and promises set forth herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

Evaluation Period: The Evaluator may evaluate two UFED InField Kiosks FT8000 v2 ("Equipment") and associated software for a period of 60 days ("Evaluation Period") free of charge. If the Product under evaluation includes software, Cellebrite hereby grants to Evaluator a limited, revocable and temporary license to use the software during the Evaluation Period. Upon the expiration or termination of the Evaluation Period, the license to use the software shall automatically and immediately terminate.

Each party agrees to keep confidential the other party's information to the extent such information is confidential pursuant to Florida law, with such care as it uses for its own confidential information, but at least reasonable care, and to only use the other party's information, to the extent such information is confidential pursuant to Florida law, for the purposes of this Agreement.

Cellebrite shall at all times retain sole title to the Product. Evaluator agrees to be responsible for any and all loss, damage or theft of the Product as the result of Evaluator's negligence. Evaluator agrees to return the Product to Cellebrite upon the expiration of the Evaluation Period or upon Cellebrite's request. If Evaluator fails to return any Product, or returns the Product in a damaged or impaired condition, ordinary wear and tear excepted, the Evaluator agrees to pay Cellebrite's then current retail price for the Product within 60 calendar days of the expiration of the Evaluation Period or upon Cellebrite's request as noted above, except that in the event the Evaluator returns the Product to Cellebrite in a damaged or impaired condition, ordinary wear and tear excepted, Cellebrite shall first return the Product to Evaluator.

Approved usages of the Product(s) are set forth in the relevant Documentation. Cellebrite assumes no liability if any Product is used in any manner other than as specified in the Documentation.

This Agreement shall be construed and interpreted in accordance with the laws of the State of Florida. Venue for any lawsuit by either party against the other party or otherwise arising out of this Agreement, and for any other legal proceeding, shall be in the courts in and for Broward County, Florida, or in the event of federal jurisdiction, in the Southern District of Florida-
