A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS FROM THE FEDERAL AVIATION ADMINISTRATION FOR THE DESIGN OF TAXIWAY FOXTROT PAVEMENT REHABILITATION AT FORT LAUDERDALE EXECUTIVE AIRPORT IN AN AMOUNT UP TO \$227,557 OR 90% OF THE COST, AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO EXECUTE A GRANT AGREEMENT REQUIRED TO ACCEPT SUCH GRANT FUNDS.

WHEREAS, the Federal Aviation Administration (FAA) is providing a grant in an amount up to \$227,557 or 90% of the costs for the design of Taxiway Foxtrot Pavement Rehabilitation at Fort Lauderdale Executive Airport; and

WHEREAS, Taxiway Foxtrot's Pavement Condition Index (PCI) will be brought up to the Federal Aviation Administration's standards of 65 PCI to provide a safe operational surface; and

WHEREAS, a task order to provide design services in the amount not to exceed \$252.841 to address the above issue has been developed; and

WHEREAS, the Federal Aviation Administration (FAA) has indicated that Fort Lauderdale Executive Airport (FXE) may proceed to award the task order pending award of the grant; and

WHEREAS, the Florida Department of Transportation (FDOT) has executed a joint participation agreement in the amount of \$17,500 to provide up to 5% of the design costs and the required grant match of \$17,500 (5%) is currently funded in the Community Investment Plan (CIP);

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Manager or his designee is hereby authorized to accept grant funds from the Federal Aviation Administration in an amount not to exceed \$227,557 or 90% of the estimated costs for the design of Taxiway Foxtrot Pavement Rehabilitation, subject to review and approval by the City Attorney's Office.

<u>SECTION 2</u>. That the City Manager or his designee is hereby authorized to execute any documents as required to accept such grant funds.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.
