MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is executed in lieu of a contract and constitutes the sole agreement between FBI-LEEDA, Inc. (hereinafter referred to "FBI-LEEDA") and the City of Fort Lauderdale on behalf of the Fort Lauderdale Police Department (hereinafter referred to as "FLPD").

FBI-LEEDA agrees to provide three (3) sessions of training to FLPD to include the following: four-day Supervisor Leadership Institute course to take place in August, 2016 at a cost of \$32,000 at the Fort Lauderdale Police Department Training Room, 1300 West Broward Blvd, Fort Lauderdale, FL. Total officers trained will not exceed 65 students.

FBI-LEEDA will cover all costs associated with instructor attendance. FLPD will be responsible for registration and coordination of attendees and securing and covering costs of training sites, handouts, refreshments and class technology.

FBI-LEEDA will invoice FLPD after the class, and payment is required within 30 days of receipt by the FLPD.


