TITLE: **REVISED PUR-13** - Motion to Approve Cancellation of Current Contract and Approval of New Contract for the Purchase of Disaster Debris Monitoring Services – Thompson Consulting Services, LLC - \$9,215,850

Recommendation

It is recommended that the City Commission cancel its current contract 625-10823 with Thompson Consulting Services, LLC (TCS), and approve a new three-year contract, in substantially the form attached, for the purchase of disaster debris monitoring services with TCS in the estimated amount of \$9,215,850; and authorize the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds.

Background

The Federal Emergency Management Administration (FEMA) recommends municipalities establish emergency debris monitoring contracts to be activated in the event of a declared emergency, such as a hurricane. This contract provides for the monitoring and reporting of the collection, processing and disposal of large quantities of debris generated by natural and unplanned events. The current contract provides for paper-based load tickets. It was rebid to allow the use of Automated Debris Management Systems, a more efficient, less labor-based method to track loads to help ensure accuracy in reporting to FEMA. The automated technology helps ensure successful monetary reimbursement from FEMA.

- On June 17, 2016, the Procurement Division issued a Request for Proposal (RFP) 865-11764 for disaster debris monitoring services to include the automated data collection.
- On July 8, 2016, three responses were received; however, one was deemed non-responsive due to lack of the required bid bond.
 - Thompson Consulting Services – Responsive
 - True North Emergency Management (TNEM) – Responsive
 - DebrisTech – Non-Responsive
- On July 28, 2016, the RFP Evaluation Committee consisting of Melissa Doyle, Solid Waste and Recycling Program Manager, Jermaine Frazier, Battalion Chief for Fire & Rescue, and Bruce Freund, Accountant for Treasury, met to evaluate

and rank the proposals from TCS and True North Emergency Management based on the following evaluation criteria:

- On August 3, 2016, the committee met again for presentations from the two qualified and responsive vendors. The two firms were ranked as follows:
 - TCS (1st Place)
 - TNEM (2nd Place)

TCS has met all requirements of the RFP specifications and has been deemed the responsive and responsible proposer recommended for award.

Resource Impact

There is no current fiscal impact to the City for this contract award. ~~Future expenditures are contingent upon approval and appropriation of the annual budget.~~

This is a pre-positioned debris contract which confirms pre-determined pricing for recovery efforts. In the event of its use, funds will be appropriated.
