| TITLE: | Motion to Approve Contract for Parking Lot Clean-Up Services at Various City Locations –Ceiling to Floor Cleaning Inc \$110,450 |

Recommendation

It is recommended that the City Commission approve a one-year contract, in substantially the form attached, with Ceiling to Floor Cleaning Inc. for the purchase of parking lot clean-up services at various City locations in the estimated amount of \$110,450; and authorize the City Manager to approve four, one-year renewal options, contingent upon appropriation of funds.

Background

On September 3, 2014, the City Commission approved a one-year contract for parking lot clean-up services with Kita Corp. in the annual amount of \$99,128 (CAM 14-1036). The contract provided for three one-year renewal options. Prior to the first renewal expiring on September 30, 2016, the City extended the contract for an additional month, through October 31, 2016. Staff chose to extend, rather than renew the contract, due to the following performance issues:

- Kita Corp. has been unable to manage their financial obligations associated with the contract.
- Kita Corp. requested the City enter into a third-party agreement for processing for payment of invoices, conflicting with the executed agreement.
- The City consistently required revised invoices due to charges added for advance payment for services not preformed.

As a result of the above vendor issues, staff decided to rebid these services. On August 23, 2016, the Procurement Services Division issued Invitation to Bid (ITB) 863-11813 for parking lot clean-up services at various City locations and received a total of eight bids. The bid received from Kita Corp. was the lowest. However, pursuant to Sections 2-184 of the Code of Ordinances of the City of Fort Lauderdale, it is recommended that the Kita Corp. be found non-responsible due to the noted performance issues. In accordance with Section 2-185 of the Code of Ordinances of the City of Fort Lauderdale, the second lowest bidder, Ceiling to Floor Cleaning, Inc.

has met all of the specifications of the bid and has been deemed the most responsive and responsible bidder recommended for award.

Resource Impact

There will be a current fiscal impact to the City in the estimated amount of \$110,450.
