TITLE: Motion to Approve Contract for Holiday Park Dog Park – Interstate

Construction, LLC - \$106,235

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for construction of the Holiday Park Dog Park with Interstate Construction, LLC in the amount of \$106,235.

Background

This project is located within Holiday Park, located at 1150 G. Harold Martin Drive, Fort Lauderdale, Florida. The project scope is to provide all labor, material, equipment, and installation necessary to construct a dog park. Work includes, but is not limited to, the installation of chain-link fence, entry archways with decorative columns, benches, concrete walkways, and a water fountain, including the water line connection.

On August 11, 2016, the Procurement Services Division issued Invitation to Bid number 163-11805. The City received four bids in response to the solicitation which was opened on September 6, 2016. The bid submitted by Interstate Construction, LLC has met all of the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid.

Due to funding constraints and bid prices received, the reduction of quantities or elimination of items is necessary to award this contract with the current available project budget. To this end, in accordance with Instructions to Bidders section - item number 14 – Deletion or Modification of Services, which states in part: "The City reserves the right to delete any portion of the Contract at any time without cause, and if such right is exercised by the City, the total fee shall be reduced in the same ratio as the estimated cost of the work deleted bears to the estimated cost of the work originally planned." Staff is requesting approval to reduce bid line item No.2 – Water Fountain, with a unit price of \$6,000 each from a quantity of two to a quantity of one. The final line item quantities to be awarded under this contract are reflected in the revised bid tabulation (Exhibit 1).

Resource Impact

There will be a fiscal impact to the City in the amount of \$106,235. Funds for this contract award in the amount of \$106,235 are available in the FY 2017 Community Investment Plan budget in the accounts listed below:
