A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA. RATIFYING MEMORANDUM OF UNDERSTANDING WITH FRATERNAL ORDER OF POLICE, LODGE 31, (FOP) TO MODIFY THE COLLECTIVE BARGAINING AGREEMENTS (CBAS) BETWEEN THE CITY AND FOP RELATED TO PROVISIONS SPECIFIC TO SPECIAL EVENT OFF-DUTY DETAILS; PROVIDING FOR REPEAL OF ANY AND ALL RESOLUTIONS IN CONFLICT HEREWITH: PROVIDING FOR REVIEW BY THE OFFICE OF THE CITY ATTORNEY PRIOR TO EXECUTION: PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Fort Lauderdale hosts and promotes special events designed to attract tourists, visitors and residents; and

WHEREAS, the City of Fort Lauderdale Police Department engages in special event off-duty detail work to provide security for City approved events; and

WHEREAS, the presence of Fort Lauderdale police officers at special events enhances the overall public health, safety and welfare; and

WHEREAS, the City believes it is in the public interest to provide workers' compensation insurance coverage to police officers when working special event off-duty details and first party property insurance coverage for city equipment; and

WHEREAS, the parties desire to amend Article 52 of both FOP collective bargaining agreements; and

WHEREAS, the City and FOP wish to enter into a Memorandum of Understanding (MOU) reflecting such changes;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale, Florida does hereby ratify and adopt the MOU with the FOP, Lodge 31, attached hereto and incorporated herein.
