TITLE: Motion to Approve Purchase of Police Boat with Radiation Detector –

Brunswick Commercial and Government Products, Inc. -\$299,904

Recommendation

It is recommended that the City Commission approve the purchase of a boat with radiation detector via General Services Administration (GSA) contract no. GS-07F-0011J from Brunswick Commercial and Government Products, Inc. (Brunswick) in the amount of \$299,904.

Background

In April 2016, the City submitted a proposal to the Department of Homeland Security, Port Security Grant Program which included the purchase of a Marine Vessel equipped with Chemical, Biological, Radiological, Nuclear and Explosive (CBRNE) capabilities. Acquisition of this boat and vehicle will enhance the Fort Lauderdale Police Department's ability to protect the City and local waterways. In September 2016, the Fort Lauderdale Police Department was notified that the proposal was approved.

The Fort Lauderdale Police Department's Marine Unit will acquire a 33 foot CBRNE rigid hull inflatable boat, which will be the largest in the Police Department's fleet and the only one with an enclosed cabin. In addition to utilizing the boat for enforcement patrols and rescue missions in bad weather and rough seas, it will be deployed for mitigation training with other agencies and for joint tactical operations. Furthermore, this CBRNE boat will enhance support to the Regional Domestic Security Taskforce as it will be utilized to enforce the port security zone, thereby protecting high value assets in and around Port Everglades.

Pursuant to Section 2-181(6) Code of Ordinances of the City of Fort Lauderdale, Florida, this purchase will be made in accordance with GSA Contract No. GS-07F-0011J from Brunswick, in the amount of \$299,904, whereby such purchase is the subject of a contract with the U.S. Federal General Services Administration.

Resource Impact

The total project cost for the police boat will be \$299,904. There is a positive fiscal impact to the City from the grant in the amount of \$224,928 and a required 25% local cash match in the amount of \$74,976.
