**TITLE:** Resolution Appointing Three City of Fort Lauderdale Citizen  
Representatives to the Broward County Aviation Department Part 150  
Noise Study Update Committees

---

**Recommendation**

It is recommended that the City Commission adopt a resolution appointing two citizen representatives to the Broward County Aviation Department Part 150 Noise Update Technical Advisory Committee and one additional citizen representative to the Study Coordination Committee.

**Background**

Broward County Aviation Department (BCAD) is undertaking a Part 150 Airport Noise Compatibility Planning Study Update to evaluate opportunities to improve the compatibility of the Fort Lauderdale-Hollywood International Airport (FLL) with surrounding communities.

BCAD has reached out to each local jurisdiction having land use authority within the Noise Exposure Map (NEM) study area to solicit representatives to serve on the Part 150 Technical Advisory Committee (TAC). In addition, a representative is also being solicited to serve on the Study Coordination Committee (SCC).

The role of the TAC representatives is advisory in nature to provide technical input on the Part 150 Study and for the designated representative to report related information back to the entity being represented. The purpose of the SCC representative is to disseminate and share information from the Part 150 Study process to the local entity being represented.

At the November 1, 2016 Commission Meeting, the Commission appointed Ms. Angelina Pluzhnyk Evans to the SCC (Exhibit 1); however, Ms. Evans prefers to serve on the TAC. Ms. Angelina Pluzhnyk Evans of the Lauderdale Isles Civic Improvement Association and Mr. Ed Rebholz of the Aviation Advisory Board have been selected to serve on the TAC. Therefore, one more citizen representative will have to be selected and appointed to the SCC to replace Ms. Pluzhnyk Evans on the SCC. In addition to these appointed committee members, there will be a Fort Lauderdale Executive Airport staff member participating as an observer on both the Technical Advisory Committee and the Study Coordination Committee.
