## MEMORANDUM OF LEASE

This is a Memorandum of Lease made and entered into as of this 2<sup>rd</sup> day of <u>becember</u>, 2016, by and between the City of Fort Lauderdale ("Landlord") and Nova Southeastern University, Inc., ("Tenant"), upon the following terms:

1. **Lease.** The provisions set forth in a written lease between the parties hereto dated October 1, 2016 ("The Lease"), are hereby incorporated by reference into this Memorandum.

2. **Demised Premises.** The Demised Premises which are the subject of The Lease are more particularly described as follows: **See Attached Exhibit "A"** 

3. **Commencement Date of Lease.** The Lease shall be deemed to have commenced October 1, 2016 as set forth within the terms of the Lease.1

4. **Term.** The Term of the Lease shall be five (5) years from the Commencement Date as stated in the written Lease. The initial term commences on October 1, 2016 and terminates on September 30, 2021.

The Lease contains and sets forth additional rights, terms, conditions, duties, and obligations not enumerated within this instrument which govern the Lease. This Memorandum is for information purposes only and nothing contained herein may be deemed in any way to modify or vary any of the terms or conditions of the Lease. In the event of any inconsistency between the terms of the Lease and this instrument, the terms of the Lease shall control. The rights and obligations set forth herein shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, representatives, successors, and assigns.

7. No Lien Rights. No liens for services, labor, or materials shall attach to the Landlord's title to the Demised Premises.
