Approval of Minutes

The minutes of the September 14, 2016 Seven Isles HOA meeting were approved by Howard Steinholz and 2nd by Carol Mashek

Resignation of board member Paula Stevens-Howard Steinholz accepted the resignation

Special Guests: Mr. Ralph Perfetto, Jihan and Sergeant Jamie Costas

Security Report

A) Mr. Ralph Perfetto

- 9/25/16 the home of Pattie Morse was vandalized by three perpetrators and they had a gun on her. It is believed this was an inside job. Over \$1M in items were stolen
- 10/9/16 at 1:30 am the police had a road block in front of 7 Isles. The police were apparently chasing a guy from Las Olas and they thought he ended up in the water behind Delmar
- A small dog, who was being walked, was hit by a green pick-up truck resulting in \$7.5K in medical bills to treat the dog
- Security found a 2nd dog wondering around
- One security guard was fired by Mr. Perfetto for failing to show up for his shift due to the weather. Ralph substituted another guard to cover the shift
 - O A discussion ensued between board members on the issues relating to this firing
 - Brian Gaines volunteered his house to be a refuge for guards in a hurricane situation. He indicated there may have been a lack of communication with the guards
 - Omar indicated we need to raise the guard's confidence level that they will be taken care of in the event of a hurricane. He indicated the guards were doing a great job
- Ralph also indicated the guards were doing a good job of installing security signs for new members and removing these signs for nonpaying members

B) Brian Gaines

- Voiced concern about construction vehicles parking on both sides of Barcelona making it very difficult to drive through
 - Sergeant Jamie indicated
 - There was no ordinance prohibiting vehicle parking on both sides of the street. There only needed to be enough room for emergency vehicles to get through
 - A ticket can only be written for non-compliant parking before a stop sign, not after a stop sign

C) Sergeant Jamie Costas

- Even though we had incidents last month, Seven Isles is still the safest community in the area
- In general crime is up in Fort Lauderdale
- Residents need to be vigilant, keep cars locked etc

Seven Isles Dr to be formally adopted as a Street name

- The HOA has been made aware by Mr. Sutcavage, property Specialist /Park Impact Fee Representative Building Services in Fort Lauderdale, that Seven Isles Dr is not an official name in Fort Lauderdale and is not on the official city map.
