TITLE: Motion to Cancel Contract with Delad Security, Inc. and Award Contract to

FPI Security Services, Inc. for Security Guard Services - \$123,603.60

Recommendation

It is recommended that the City Commission cancel the contract with Delad Security, Inc. and award a one-year contract to the third lowest cost, responsive and responsible bidder, FPI Security Services, Inc., in substantially the form attached, for the purchase of security guard services at the Fiveash Water Treatment Plant (Fiveash) in the amount of \$123,603.60; and authorize the City Manager to approve three one-year renewal options contingent upon appropriation of funds.

Background

One June 8, 2016, the Procurement Services Division issued Invitation to Bid No. 163-11772 and received a total of 17 bids. On August 16, 2016, the City Commission awarded a contract for the purchase of security guard services at Fiveash to the lowest cost, responsive and responsible bidder, Florida Executive Security Agency, Inc., subject to meeting the terms of the contract (CAM 16-0839). After this award, Florida Executive Security Agency, Inc. chose to withdraw and notified the City of same on October 14, 2016. The company did not perform any work for the City.

Due to this withdrawal, on November 15, 2016, the City Commission approved contract award to Delad Security, Inc. (Delad). Delad was unable to fulfill the contractual obligations and was issued a cure notice on December 6, 2016. Delad was subsequently released from their contract for non-performance. Due to the sensitive nature of the security services, and in accordance with Section 2-174 (b) (3) of the Code of Ordinances of the City of Fort Lauderdale, the Purchasing Manager, with the approval of the City Manager, has deemed Delad as an irresponsible vendor and prohibited from work for the City for a period of one year.

This request is for a contract award to the third lowest-priced bidder, FPI Security Services, Inc., to provide armed Level C security officers at the Fiveash facility by providing roving and foot patrol services 365 days a year, including holidays.

Procurement Services has reviewed the original 17 bids again and determined that FPI Security Services, Inc. is the third lowest cost, responsive and responsible bidder.

Resource Impact

There will be a current fiscal year impact to the City in the amount of \$123,603.60.
