**M-2**     [16-1332](#)     Motion to Approve a Streetscape Enhancement Funding Agreement Between the Fort Lauderdale Community Redevelopment Agency and FLL Land Holdings, LLC for the ID Flagler Village Project - \$251,078

Bob Wojcik, Community Redevelopment Agency (CRA) Planner, outlined and explained the pertinent details involving the project of this motion, a three-story townhouse project located at 103 Sistrunk Blvd.

Chair Seiler asked about the Community Redevelopment Agency Advisory (CRAA) Board's vote recommending this project and it was stated that the vote was 7-4 in favor of the project and the dissenting votes were in favor of incentivizing maximum density housing in this area. It was noted that the incentive per unit will be \$10,000.00. Comments and discussions continued on the project's details

including utility easements and the landscape strip.
