

**PROJECT DESCRIPTION:**

Marine commerce and recreation are among the leading industries in greater Fort Lauderdale/Broward County. With more than 165 miles of navigable waterways and 7 miles of coastline within our jurisdictional boundaries alone, the City of Fort Lauderdale serves as primary host to a variety of aquatic related business and activities. These include marinas, waterfront establishments, charter cruises, and boat manufacturing, repair and storage facilities. The City also serves as host to the Fort International Boat Show, the Tortuga Festival and the Winterfest Boat Parade. As a result of the plethora of marine businesses and recreational activities occurring within our uniquely situated municipality, the City of Fort Lauderdale regards marine law enforcement patrols as highly essential to ensuring the safety of our navigational waterways and to maintaining overall public safety within our jurisdiction.

**Enhanced Law Enforcement: \$144,340**

The Fort Lauderdale Police Department's Marine Unit is responsible for providing law enforcement coverage for Fort Lauderdale's beach, intercostal waterway and expansive network of canals. Currently staffed by one (1) sergeant, seven (7) sworn officers and one (1) police service aide, the Marine Unit patrols the City's navigable waterways between 0700 – 1700 hours, seven days per week. Given this limited number of officers and the City's current budgetary constraints, effective law enforcement coverage of our expansive waterways is challenging.

To bolster our efforts to provide marine-related policing services in FY 2017-2018, the Fort Lauderdale Police Department (FLPD) is requesting a total in \$142,340 in Enhanced Marine Law Enforcement funding. The requested funding would allow for the addition of 3,235 hours of marine law enforcement patrols after 4:00PM Mondays – Thursdays, and between 4:00PM on Fridays to 11:59PM on Sundays. As currently proposed, receipt of EMLEG funding for *Operation Venice of America* would not only improve our ability to meet the continuous demands for law enforcement services on our City's waterways, it will also allow our officers to provide/distribute marine safety education information to citizens during the extended enforcement hours.

Based on the below-listed rationale, our Department also wishes to request the ability to include the following events' dates as allowable under our proposed 2017/2018 EMLEG request: the Fort Lauderdale International Boat Show, the Winterfest Boat Parade and the Fort Lauderdale and Pompano Beach Holiday Boat Parades.

- *Fort Lauderdale International Boat Show (November 2 - 6, 2017):* Fort Lauderdale PD Marine Unit officers work this event as an off-duty vendor paid detail assignment between 1400 – 2400 hours, Thursday – Monday. On the event dates, it would be beneficial to the furtherance of the EMLEG objectives to allow for augmented marine patrols before the detail assignment hours. These patrols could be worked by present and/or approved auxiliary Marine Unit officers.
- *Fort Lauderdale Winterfest Boat Parade (December 2016):* Fort Lauderdale PD Marine Unit officers work this event as an off-duty vendor paid detail assignment from 1400 – 2400 hours. On the event date, it would be beneficial to the furtherance of the EMLEG objectives to allow for augmented marine patrols before the detail assignment hours. These patrols could be worked by present and/or approved auxiliary Marine Unit officers.
- *Pompano Beach Holiday Boat Parade (December 2016):* This event occurs outside of the jurisdiction of the Fort Lauderdale Police Department and FLPD Marine Unit officers are not hired as detail officers for this event. Thus, it would be beneficial to the furtherance of the EMLEG objectives to allow for augmented marine patrols on the event date within all of the Fort Lauderdale Police Department's EMLEG Zones (IV-A, V, VI and VI-A).

As in prior years, the City anticipates that the additional patrol hours during peak weekend boating times coupled with the aggressive evening patrol hours made possible through the grant's funding, will continue to prove effective. Specifically, the enhanced law enforcement presence and waterway enforcement will allow for increased opportunities for public contact and boater safety education, while reducing boating accidents. And while the overall impact and influence of the additional police presence cannot be wholly quantified, this increased police presence will undoubtedly have a positive impact on the public's overall perception of waterway safety in our City/County.

#### **Officer Training: \$2,000**

An additional component of this grant would be the participation of two officers in Marine Law Enforcement classes. The primary objective of the training would be to expose marine law enforcement officers to a variety of water-related issues that they are likely to encounter while conducting marine patrols.

**Staffing:** The Police Department's Marine Unit is currently staffed at one (1) sergeant, seven (7) sworn patrol officers and one (1) police service aide. These officers patrol our waterways from 0700 – 1700 hours, seven days per week. Between the above-referenced hours, officers patrol the waterways; investigate boating accidents, vessel and marina burglaries, vessel thefts, and environmental spills; perform safety inspections; and disseminate boater safety information. Although it appears that our stated patrol hours/coverage is sufficient, when you consider the number of navigable waterway miles (165 miles) that need to be patrolled within our City, and the diversity of activities the officers perform, the challenges associated with proactively patrolling these areas absent EMLEG grant funding becomes readily apparent. In addition to the eight (8) Officers assigned to the Marine Unit, the department also has six *auxiliary* officers that are able to perform aggressive patrols as bravo units. Auxiliary officers are non-full time Marine Unit officers that have had operator training and are either former Marine Unit officers now assigned to another departmental division, or members of our department's Dive Team and/or SWAT Waterborne Response Team. It should be noted that absent EMLEG funding, these officers could not be utilized to assist with these patrols.

**Training:** Every sworn Fort Lauderdale Police Officer that patrols the City's waterways receives 80 hours of training before they are allowed to go "solo" on the water. This training is divided into two parts: 1) operational instruction; and, 2) book instruction from portions of the Chapman's Handbook and other applicable Federal, State and Local statutes.

In addition to the two-part training, officers must pass two written exams; must satisfactorily perform certain operational maneuvers; and, must pass a final skills exam that requires them to perform numerous maneuvers under the most adverse conditions possible. The officers must also complete mandatory re-training hours.

Finally, in order to maintain his or her law enforcement certification, each officer is required by the State of Florida to accumulate 40 hours of additional training every three years. The Fort Lauderdale Police Department, however, mandates that our officers complete 40 hours of training every year.

All of the aforementioned training is documented, with duplicate copies forwarded to the Police Department's Training Division.

4. DESCRIBE HOW THE PROPOSED GRANT PROJECT WOULD IMPROVE BOATING SAFETY IN BROWARD COUNTY.

The proposed EMLEG grant funding will enable the City to continue additional aggressive evening patrols during weekdays and other patrols during peak boating times on the weekends. These additional grant funded patrols will allow our Department to positively contribute to the overall improvement of boating safety within the County by facilitating additional opportunities for our officers: to make additional contact with citizens who use the waterways; to provide boater safety information to citizens; to provide area checks of key marine locations; to make additional vessels stops and/or conduct additional safety inspections of vessels; to issue warnings and citations for noted violations; and, to prevent boating accidents through the aforementioned proactive marine patrol activities.

Due in part to the success of the EMLEG program, over the past few years the City has experienced an overall appreciable reduction in waterway related incidents, waterway related accidents and waterway related crimes. The grant funding has also enabled our officers to increase the public's awareness of boating safety through the distribution of safety booklets provided by the Marine Industries Association. Based on these and other positive results experienced by our Department through previous EMLEG grant funding, we can confidently expect that the receipt of EMLEG grant funding in FY2017-2018 will enable us to continue contributing to overall boating safety within Broward County.

**Recommendation**

It is recommended that the City Commission approve a motion authorizing the submission of a grant application under the Broward County Enhanced Marine Law Enforcement Grant Program

**Background**

The Broward County Marine Advisory Committee is accepting grant proposals for the Fiscal Year 2017/2018 Enhanced Marine Law Enforcement Grant (EMLEG) Program. The purpose of the EMLEG Program is to improve boating safety in Broward County by enhancing or supplementing marine law enforcement activities and improving boating safety education. This request is for authorization to apply for EMLEG funds. If awarded, grant funds will be used to assist in enforcement activities on the City's waterways through the provision of 3,235 hours of additional waterway law enforcement patrols. Enhanced Marine Law Enforcement Grant funding allows the Department to schedule Marine Unit officers to work evening shifts at a reduced cost to the City. Absent EMLEG funding, the Department would be unable to schedule Marine Unit personnel during evening shifts.

Although the grantor does not require a cash match, the program's reimbursement rate of \$44/hr will not cover all associated staffing costs including overtime salary rates and FICA costs of approximately \$83,668.68. The Department normally obtains the additional funds necessary to support the EMLEG award during the City's annual budget process.

The grant application deadline is January 20, 2017 and a motion supporting the funding request must accompany the application submittal. The proposed grant project period is October 1, 2017 – September 30, 2018.

**Strategic Connections**
