TITLE:	Motion to Approve a Memorandum of Understanding with Swim Fort Lauderdale Masters Booster Club. Inc

Recommendation

It is recommended that the City Commission approve a motion allowing the proper City officials to enter into a Memorandum of Understanding with the Swim Fort Lauderdale Masters Booster Club, Inc. to support the City's competitive sanctioned U.S. Masters swim meets held at the Fort Lauderdale Aquatic Complex.

Background

Acknowledging the importance and value of volunteers and to assist in administrative tasks relative to certain competitive swimming meets at the City's Aquatic Complex, the Parks and Recreation Department was authorized by the City Commission in February of 2016 to enter into a Memorandum of Understanding with Swim Fort Lauderdale Masters Booster Club, Inc., which allowed the continuation of a successful partnership with regard to the competitive sanctioned U.S. Masters swim meets conducted at the Aquatic Complex. As such, the Parks and Recreation Department is once again desirous of entering into a Memorandum of Understanding (MOU), with Swim Fort Lauderdale Masters Booster Club, Inc., (Booster Club), a booster club to support the City's competitive sanctioned U.S. Masters (adult) swimming team, Swim Fort Lauderdale, for events scheduled February – December 2017.

The Booster Club will continue to be responsible for a number of administrative responsibilities relative to meets; such as, providing volunteer support necessary to fill essential event operations such as the co-meet director and Hytek Meet Manager software operator who is responsible for "constructing" the electronic meet file to run the swim meet, process all athlete meet entries and create the meet heat sheets.

Booster Club volunteer support will also continue to assist with procuring official U.S. Masters Swimming meet officials to conduct the meet within the established U.S. Masters Swimming guidelines and secure all lane timing staff, event registration/check- in staff, and meet announcer. the revenue for the meet. Half of the net revenue will go to the Booster Club and half will go to the City.

Revenue generated will cover costs and expenses related to the team swim meets, as well as help off-set the costs of the following, including but not limited to, team scholarships, team travel costs, and continuing coaches' education.

The Agreement will begin on February 7, 2017 and end whichever may come first: December 31, 2017; the date the Aquatic Complex closes; or the date the City determines is necessary in order to facilitate the closure of the Aquatic Complex for rehabilitation of the Aquatic Complex. The date will be evidenced in writing by the City.

Either party may terminate this Agreement at any time upon thirty (30) days written notice to the other party.

Resource Impact

There is a positive fiscal impact in the estimated amount of \$5,000. Revenue related to this agreement is included in the FY 2017 operating budget in the account listed below.
