TITLE: Motion to Approve Contract for Purchase of Instrumentation Control Data

Management Services - Revere Control Systems, Inc. - \$603,000 (three-

year total)

Recommendation

It is recommended that the City Commission award a contract, in substantially the form attached, to Revere Control Systems, Inc. (Revere) for the purchase of instrument control data management services at an estimated cost of \$603,000 for the three-year term; and authorize the City Manager to approve two, one-year renewal options, contingent upon the appropriation of funds.

Background

This procurement of instrument control data management services is to assist with the maintenance of the Supervisory Control and Data Acquisition (SCADA) and operational control systems of the City's utilities infrastructure. Revere will configure, maintain, enhance, repair, and perform detailed system diagnostics, programming, and upgrades. Revere will also provide documentation and training for all systems and software to ensure enhanced system reliability, functionality, and usability.

The Procurement Services Division issued Request for Proposals (RFP) No. 465-11670 and received only one bid on September 14, 2016. The Procurement Services Division reviewed the bid and determined that Revere's bid was fair and reasonable. Revere has met all of the specifications of the RFP and has been deemed a responsive and responsible bidder.

Funds for this purchase in the amount of \$201,000 are available in the FY 2017 Budget and Community Investment Plan as detailed below.
