Mayor Seiler announced, in conjunction with the organization of Sister Cities, the welcoming and introduction of City of Gold Coast Councillor Division 10 Paul Taylor. Mayor Seiler continued his comments citing the Sister Cities relationship being in place since 1980 and reaffirmed in 2010. He cited the strong trade relationship between the City and the City of Gold Coast via the free trade agreement between Australia and the United States. Mayor Seiler cited the many beneficial aspects of the trade agreement for both countries. He also highlighted the many similarities between the City of Gold Coast with the tourism and marine industries.

Mr. Rosenthal congratulated the City Attorney's Office and its professional staff for negotiating this financially responsible settlement on a legal issue that could have cost the City much more. Mr. Rosenthal also commented that the City has a City Staff as good as any in America.

Mayor Seiler recognized Charles King, 105 N. Victoria Park Road, who addressed the Commission. Mr. King's comments focused on the lack of information in this item's backup.

Vice Mayor Trantalis acknowledged that this issue was a tragedy that was perpetrated on this individual and it behooves the City to vote affirmatively on this item. He also commented that keeping the involved officers on the City's payroll bothers him, noting their egregious conduct.

Vice Mayor Trantalis addressed City Manager Feldman stating he would support this item with the proviso that he reconsiders keeping these officers on the City's payroll.

Commissioner Roberts agreed with Vice Mayor Trantalis that this was a mistake and the City is trying to make amends for this error. He further clarified that other agencies and authorities have responsibilities in charging an individual. As such, other areas of the criminal justice system had also failed in this situation.

Mr. King noted that this settlement is unprecedented and the City is under no obligation to pay residents for damages resulting from ruptured sewer pipes and this sets a dangerous precedent. He further commented on the need to address the City's infrastructure issues.

Vice Mayor Trantalis commented on the City not having a legal obligation to pay this. He asked City Attorney Everett if this was still the opinion of her office. City Attorney Everett stated her office had not had an opportunity to weigh in on this matter. She stated the City Manager's office handled this matter in conjunction with the City Manager's Risk Division and confirmed there has not been a legal liability discussion in her office. Vice Mayor Trantalis commented that further claims will likely be forthcoming from residents who suffered. Commissioner Rogers recommended taking these on a case by case basis and in this particular instance involved those most impacted and he felt this is the right thing to do. Further discussions and comments continued on the residents who suffered the worst damage from the sewer pipe breakage, the costs, and the safety and health issues involved.

Ms. Kielian's comments focused on her support of this resolution thanking the Commission for overcoming the stigma of addiction and stating the problem must be addressed at the City, County, and State levels. She noted the root of the problem begins with the legally overprescribing of painkillers and spoke addressed additional aspects of opioid addiction.

Mayor Seiler and Commissioner Roberts thanked Ms. Kielian for her

steadfast, active role in assisting the City with this issue.

Mayor Seiler noted the outstanding presentation from the City's Police Department and Fire Department at the Commission Conference Meeting held earlier today, recommending Ms. Kielian obtain a copy of the presentations and backup materials.

Mayor Seiler recognized Heather Davidson who addressed the Commission on behalf of the United Way as Interim Director on Public Policy for Broward County. Ms. Davidson's comments were in support of this resolution addressing the overprescribing of opioids and opioid usage. Ms. Davidson noted her background in social work and advocacy, stating she has never seen the high levels of death with the opioid addiction crisis. She noted the resolution is based upon the CDC prescribing guidelines of opioids as 3-5 day supply for acute pain, rather than a 30 day supply for a first time patient. Ms. Davidson noted this crisis's statistics across Broward County and the entire country. She thanked the Commission for allowing her to speak and the Commission's work to focus on preventive measures regarding this issue.

Mayor Seiler thanked Ms. Davidson for her work on prescription drug abuse.

# **ORDINANCE FIRST READING**

# **OFR-1** <u>17-0008</u> Ordinance Establishing a Moratorium on the Cultivation, Processing, Dispensing or Retail Sale of Cannabis for a Period of 180 Days

Mayor Seiler recognized Ron Book who addressed the Commission on this item. Mr. Book's comments focused on his pharmaceutical client's preference to see a model ordinance adopted rather than a moratorium for 180 days. He recognized that the 180 timeframe allows City Staff to draft an ordinance. Mr. Book urged the Commission to have a smaller timeframe and should consider putting together a working group to include members of the community, and members of the industry. He stated the goal is to have a regulatory scheme that works for City's communities. He urged that there be a limitation on the number of dispensaries and expounded on his thoughts on what the State legislature intended for this issue. Further discussion ensued on the number of dispensaries and their locations within the City.

Vice Mayor Trantalis agreed on the need to do this soon and not be preempted by the State legislature and would be similar to what happened with the Vacation Rental issue.

Mayor Seiler recognized Charles King, 105 North Victoria Park Road, who addressed the Commission stating his viewpoint that the City should put strict rules in place on this issue as soon as possible so these ordinances could be in place prior to any legislation implemented at the State level.

Mayor Seiler commented on the need to establish a moratorium on this matter to allow City Staff to thoroughly address this issue and come up with the correct ordinance language. He stated he would like to see the number of dispensaries limited to four or less, and properly zoned within the City. Mayor Seiler also recommended a shorter timeframe of 90 days and create a task force including the industry to ensure the City does this correctly.

Vice Mayor Trantalis emphasized the need to give the appropriate direction. Commissioner Rogers recommended doing a study of how it should be regulated in terms of numbers, distance, and population. He noted several cities have prohibited it and may cause the City to have a concentration of these dispensaries. Mayor Seiler stated the City of Hollywood has moved forward on this matter.

Commissioner Roberts commented on the need to have a task force and the number of dispensaries needs to be based on medical legitimacy. He also noted the need to draft an ordinance in less than 180 days. He commented on possible future legislation that could make the use of marijuana more open and the need to avoid a situation similar to the one the City previously experienced with pill mills. Commissioner Roberts also commented on the current situation regarding this issue in Colorado, emphasizing the need to prevent this in the State, Broward County, and the City.

Commissioner Rogers noted that marijuana is still a Schedule I drug and banks cannot accept the profits from the sale of marijuana. Mayor Seiler noted the State's health officials silence on this issue. Further discussions ensued and Vice Mayor Trantalis addressed City Manager Feldman stating his staff should use the moratorium timeframe to research and determine the nexus of the medical need for marijuana, the recommended quantity of dispensaries, and proper location within the City based on zoning.

City Manager Feldman requested clarity and stated his preference to develop regulations in conjunction with the input of the industry groups, bring those recommendations to the Planning and Zoning Board, and then to the City Commission before the expiration of the moratorium.

Commissioner Rogers discussed the importance of the City regulating this issue should the State legislature and State administrative agencies not. Mr. Book stated that the administrative agencies will not take any action until the legislature has acted. Mayor Seiler recommended the task force should begin with looking at what other cities have drafted as a starting point to develop the City's ordinance. City Attorney Everett confirmed that the National League of Cities has already circulated this type of information.

The Commission confirmed they would like to see language for an ordinance in 45 days. Commissioner Roberts noted there would be community involvement and input regarding the location of the dispensaries.

Assistant City Attorney D'Wayne Spence commented on the cultivation and processing of medical cannabis that is preemptive to the State. The City Attorney's Office needs clarification as to the local rule with regards to citing facilities for the cultivation and processing of medical cannabis because of the definition in the current law that expands to this use as well. Discussions continued on this topic.

Mayor Seiler confirmed that City Staff will have a workshop meeting with the industry and recommended a 45 day timeline for the City Staff to come back to the Commission with a draft of the ordinance.

Commissioner McKinzie affirmed the importance of receiving input from both the industry and City Staff.

Vice Mayor Trantalis introduced this ordinance of First Reading as amended which the City Clerk read by title only.
