**TITLE:** **REVISED PUR-4** - Motion to Approve Continuing Contracts for  
Construction Engineering Inspection Services – Various Consultants -  
\$1,484,000 (two-year total)

**Recommendation**

It is recommended that the City Commission award continuing contracts for construction engineering inspection (CEI) services, in substantially the form attached, with the top five ranked firms: R.J. Behar & Company, Inc.; Michael Baker International, Inc.; Amec Foster Wheeler Environment & Infrastructure, Inc.; Craven, Thompson & Associates, Inc.; and Calvin, Giordano & Associates, Inc. in the estimated aggregate amount of \$1,484,000. This amount is for an initial two-year term and is to be distributed among the consultants following the normal task order approval process. Staff also recommends approval for the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds.

**Background**

On ~~September 7~~ August 16, 2016, the City Commission approved negotiations with the top five ranked firms: R.J. Behar & Company, Inc.; Michael Baker International, Inc.; Amec Foster Wheeler Environment & Infrastructure, Inc.; Craven, Thompson & Associates, Inc.; and Calvin, Giordano & Associates, Inc. (CAM 16-095146-0343). Negotiations with all firms were successful and are therefore included in this approval request.

The selected firms will provide CEI services under a continuing contract as authorized by individual task orders for individual projects. It is the intent of the City to use the selected firms on an as-needed basis. The specific scope of work and fee schedule for each firm will be individually agreed upon by the City and the consultants. These contracts will be used to advance many important initiatives and projects. Should the funding allocation of \$1,484,000 be depleted, staff will request City Commission approval of additional funding.
