Investment Projects – Sun-Up Enterprises Inc. - \$2,733,061 (two-year  
total)

**Recommendation**

It is recommended that the City Commission approve a two-year contract award, in substantially the form attached, to provide services for various Transportation and Mobility Department community investment plan projects and maintenance and repair projects to Sun-Up Enterprises Inc. (Sun-Up), in the estimated amount of \$2,733,061; and authorize the City Manager or designee to approve two, one-year renewal options contingent upon appropriation of funds.

**Background**

The work includes furnishing all labor, tools, equipment, materials and supplies to complete various projects including traffic calming infrastructure, new parking lot construction, as well as parking facility projects to bring City facilities into compliance with Americans with Disabilities Act (ADA) guidelines. The work anticipated under the proposed contract also includes asphalt and concrete repairs, installation of compacted limerock base, construction of greenways and sidewalks, seal-coating, temporary parking space striping, painted and thermoplastic parking space striping, pavement markings including bike lanes and midblock crosswalks, pedestrian and school zone signalization, ADA compliant curb ramps and parking related signage as needed. The identified projects and estimated amounts are provided below.

All services under this contract will go through the task order process and will be within the overall authorized amount and for services eligible and outlined within the contract. There may be tasks/projects that are not listed above that will go through the task order approval process based on being an already approved budgeted task or project within the City's Annual Operating Budget and Community Investment Plan.	

Invitation to Bid No. 273-11832 was opened on December 16, 2016 and three bids were received. Sun-Up is deemed to be the lowest responsive and responsible bidder.
