## FIRST AMENDMENT TO AGREEMENT FOR BACKFLOW PREVENTION AND PLUMBING SERVICES

**This First Amendment** ("Amendment") is entered into on March \_\_\_\_\_, 2017 by and between the City of Fort Lauderdale, a Florida municipality (hereinafter "City") and Pipeline Plumbing Services of Broward, Inc., a Florida corporation (hereinafter "Contractor"), individually referred to herein as "Party" and jointly referred to as "Parties" for the purpose of amending AGREEMENT FOR BACKFLOW PREVENTION AND PLUMBING SERVICES, Invitation to Bid (ITB) No. 463-11775 (hereinafter "Agreement"), dated November 1, 2016.

WHEREAS, an Agreement for backflow prevention and plumbing services was awarded in the amount of \$590,570.00 by the City Commission on November 1, 2016; and

WHEREAS, Section III of the Agreement has a contract period of one (1) year, with four (4) one (1) year renewal options; and

WHEREAS, the Parties wish to amend the Agreement to change the contract period to an initial three (3) year contract period, with two (2) one-year renewal options; to be consistent with the ITB; and

WHEREAS, the City agrees that all other terms and conditions in the original contract remains the same; and

WHEREAS, the Parties desire to amend the Agreement by this writing to reflect the amended or additional terms and conditions to which the Parties have mutually agreed to;

Now, therefore, in consideration of the mutual covenants, promises, and consideration set forth herein, the Parties agree as follows:

1. Section III. Term of Agreement is hereby amended to change the initial term to November 1, 2016 and ending on October 31, 2019, with two (2) one-year renewal options.

2. In the event of an explicit conflict between this Amendment and the Agreement, the terms and conditions of this Amendment shall take precedence in the interpretation of the explicit matter in question.
