TITLE: Resolution Authorizing the Execution of Agreements with the Broward

County Property Appraiser's Office for Collection of Special Ad Valorem and

Non-Ad Valorem Assessments

Recommendation

It is recommended that the City Commission adopt a resolution authorizing the execution of agreements with Marty Kiar as the Broward County Property Appraiser, related to administration of the City's non-ad valorem and special ad valorem tax rolls.

Background

The City of Fort Lauderdale entered into several written agreements with Lori Parrish, as Broward County Property Appraiser ("Property Appraiser") to provide for the reimbursement of necessary administrative costs incurred by the Property Appraiser and associated with the creation and maintenance of special ad valorem and non-ad valorem assessment rolls for properties within the City. Each agreement contained a clause automatically terminating the agreement at the end of the Property Appraiser's term of office. Lori Parrish's term of office ended on January 3, 2017. The attached resolution authorizes the proper City officials to execute agreements with Marty Kiar as Property Appraiser.
