TITLE: Resolution Adopting the Consolidated Budget Amendment to Fiscal Year
2017 – Appropriation

Recommendation

It is recommended that the City Commission adopt a resolution amending the Fiscal Year 2017 Budget and Community Investment Plan (CIP).

Background

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff is recommending that the City Commission amend the FY 2017 Operating Budget, Community Investment Plan, and personnel complement by approving the following transfers and appropriations:

Community Redevelopment Agency (CRA)

A. Transfer Between Funds – CRA Business Incentives Fund, General Fund – Land Acquisition – \$612,291

Section 8.02 of the City Charter allows the City to convey real property owned by the City to another public agency for a public purpose. Commission Memo Agenda #17-0044 was presented as a Commission item on January 18, 2017. This item involves the conveyance of fifty-five (55) properties for residential use throughout the NPF Community Redevelopment Area.

At the CRA Board meeting of December 20, 2016, the CRA Board voted in favor of recommending to the City Commission the transfer of these properties from the City to the CRA for \$3,000 per parcel (\$165,000) plus all costs. The costs include but are not limited to attorney's fees, title examination, closing service fees, recording costs, title policies, and survey along with expenses that may be necessary to clear any title defects that may exist on these properties in order to allow end users to use them for redevelopment (\$447,291). The Affordable Housing Trust Fund will receive \$165,000 from this transaction.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$612,291 to transfer funds appropriated for business incentives to be used for this land conveyance transaction. CAM #17-0199 is associated with this item.

Parks and Recreation

B. Budget reduction and elimination of 2 Part-Time Positions from the City's Personnel Complement – General Fund – Daily Maintenance Services along Sistrunk Boulevard – (\$42,765)

A budget amendment was approved on October 5, 2016 (CAM #16-1088) for the appropriation and addition of three (3) part time positions to the City's personnel complement for daily maintenance services along Sistrunk Boulevard. Staff determined that only a single part-time position is required to maintain Community Redevelopment Agency (CRA) owned properties on Sistrunk Boulevard. City owned properties would be maintained by existing staff.

Staff recommends that the City Commission amend the FY 2017 Personnel Complement by removing two (2) part-time employees and amending the budget in the amount of \$42,765 for daily maintenance services along Sistrunk Boulevard.

C. Transfer Between Capital Projects – Park Impact Fee Fund – Park at Riomar – \$70,000

Park Impact Fees in the amount of \$70,000 were appropriated to a general beach capital project until a more specific project could be identified. Staff is requesting these funds be transferred for a "pocket" park which is being considered for the corner of Riomar Street

and Bayshore Drive. The park will include walking and biking trails for walkers and bikers to use as a way point along a daily exercise routine. It will be an extension of the Central Beach Master Plan, which calls for Riomar Street to be a “people street.”

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$70,000 for the park at Riomar.

D. Appropriation of Grant Funds - Grant Fund – American Red Cross Learn to Swim Program - \$12,650

The City of Fort Lauderdale was awarded funding in the amount of \$12,650 from the American Red Cross for the continuation of the Red Cross Centennial Campaign to conduct swim lessons and water safety related courses at a reduced rate to the community as part of an agreement for three consecutive years; it is the final year of the three year agreement. The funding will cover staffing and program costs. No cash match is required.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$12,650 for the American Red Cross Learn to Swim Program.

E. Appropriation of Subsidiary Funds – General Fund – Repairs at Carter Park - \$70,000

Public Works engineering staff is working with Parks and Recreation staff to address Carter Park flooding problems. The improvements proposed include the installation of a new concrete slab over an existing one, installation of storm pipes to alleviate flooding problems in the ball cages, and improvements to the north parking area. Funds are available in a General Fund subsidiary account for renovations at Carter Park.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$70,000 to facilitate the repairs at Carter Park.

F. Transfer Between Capital Projects – General Fund – Snyder Park Boardwalk Replacement – \$130,000

A project was approved to facilitate the replacement of the Snyder Park Boardwalk on the west side of the lake. Florida Recreation Development Assistance Program (FRDAP) grant funds of \$50,000 were also given to assist in the replacement of the boardwalk.

In order to complete the boardwalk, additional funds are required. Funding in the amount of \$130,000 is available in the Snyder Park Dock, Ramp and Pavilion Project. As the projects have similar scopes, staff is recommending that they be combined.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan (CIP) in the amount of \$130,000 to facilitate the completion of the Snyder Park Boardwalk Replacement.

G. Addition of 5 Full Time Positions to the City's Personnel Complement – General Fund – Pool Lifeguards - \$0

The Parks & Recreation Department is requesting the addition of five (5) full-time pool lifeguard positions in an effort to secure personnel with a diverse skill set in support of aquatics safety, recreational programming and to create opportunities for workplace advancement and training. Three (3) of these positions will be assigned to the Aquatic Center and two (2) will be assigned to community pools. The positions will be funded in FY 2017 through a reduction in part-time hours currently worked by temporary Life Guards and operational savings realized related to the delayed opening of South Side School.

Staff recommends that the City Commission amend the FY 2017 Personnel Complement by adding five (5) full time Lifeguard II positions. There will be no current fiscal year impact; the net annual impact on future budgets is estimated at approximately \$100,000.

Transportation and Mobility

H. Appropriation of Grant Funds - Airport Fund - Airfield Lighting Rehabilitation - \$438,106

The City of Fort Lauderdale was awarded a supplemental grant of up to \$438,106 from the Florida Department of Transportation (FDOT) for airfield lighting improvements at the Fort Lauderdale Executive Airport. This project is for the replacement of airfield taxiway and runway quartz edge lights with light-emitting diode edge lights, replacement of airfield navigational aids, installation of a new light beacon tower, cabling, conduits, base cans, installation of an airfield lighting arrestor system, and modifications to the airfield electrical vault. FDOT has provided a Supplemental Joint Participation Agreement (SJPA) in the amount of \$438,106 for the construction costs. The required grant match amount of \$109,527 is available in the current project budget.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$438,106 for the airfield lighting improvements.

I. Appropriation of Unanticipated Revenue, Ratification of Prior Year Expenditures, and Transfer between Funds - Grant Fund, General Fund – Clean-up of Gas Tax Local Alternative Dollars for Multiple Years - \$444,125

Staff is requesting the City Commission to ratify prior year expenses in the multi-year GTRANSIT grant index code that was historically used to track Gas Tax revenues used as grant match contributions towards Community Bus operations. It is also requested

that the balance of funds due to actual revenues in excess of actual expenditures in the amount of \$86,026.54 be transferred to the General Fund Community Bus Operating Budget for FY 2017.

Gas Tax revenues deposited into this grant index code for FY 2001 - FY 2016 totaled \$3,555,073.30 and the actual expenditures for these same years were \$3,469,046.76. The remaining balance, based upon actual revenues and expenditures, equates to the \$86,026.54. Since these funds were never appropriated although expenditures were posted for fiscal years 2011 and 2012 the grant index overspent the authorized budget in the amount of \$444,125.30. Because the index is multi-year and cumulative, some of the years were overspent and other years underspent. The Transportation and Mobility Department began managing the GTRANSIT index in 2013.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$444,125 for the clean-up of gas tax local alternative dollars for multiple years.

**J. Appropriation of Fund Balance – Airport Fund – Executive Airport Parking Lot
- \$1,333,500**

The Fort Lauderdale Executive Airport has received numerous requests from airport tenants and rental car businesses for additional parking areas for their staff and rental cars. The construction of a 300 parking space parking lot will be used as a means of increasing the Airport's non-aviation revenue stream by charging a pre-determined rate for use of the parking lot by airport tenants and/or other businesses. The parking lot will also alleviate the overflow parking issues that certain airport tenants experience. The construction will take place on a six (6) acre vacant property located north of Commercial Blvd and NW 21st Avenue. The project will include site clearing, earthwork, paving, landscaping, concrete perimeter wall, and security cameras. The required funding amount of \$1,333,500 is available in the Airport's Fund Balance.

Staff recommends that the City Commission amend the FY 2017 Budget and Community Investment Plan (CIP) in the amount of \$1,333,500 for the Executive Airport Parking Lot Project.

Public Works

K. Appropriation and Transfer of Fund Balance – Fleet Service Fund, Sanitation Fund, Water and Sewer Fund, Stormwater Fund, and General Fund – First Vehicle Services Contract - \$217,292

The City of Fort Lauderdale contracts all vehicle maintenance service through First Vehicle Services (FVS). This contract allows for an adjustment in the contract costs in the event that the number of vehicles allocated by vehicle class increases or decreases by ten (10) percent or more. An analysis performed on the overall fleet size effective September 1, 2016 demonstrated increases to the Refuse Truck class due to the transition of bulk collection vehicles from dump trucks and loaders to claw trucks. In addition, the Fire Ambulance and Fire Command Unit vehicle categories were increased due to an enhanced level of service funded in the Fire-Rescue Department. Other vehicle classes that experienced increases exceeding 10 percent include: Small Equipment Pump, Grounds-Small (mowers), Street Sweeper, Heavy Truck-Water, Excavator, Medium Truck – Flat Bed, Police-Hot Seat, Light Vehicle-SUV 4x4, Light Vehicle-Auto/SUV-4x2, and Light Vehicle.

FVS approached staff and requested an adjustment be made to accommodate their increased staffing needs and operational costs related to the increased number of vehicles they are maintaining. Staff worked with FVS to develop an acceptable methodology to determine the additional contract expense of \$217,292 for Fiscal Year (FY) 2017.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$217,292 for the First Vehicles Services Contract.

L. Appropriation of Fund Balance – Fleet Service Fund, Airport Fund – Transfer of Executive Airport Van - \$4,456

After the receipt of the 15-passenger Ford van, the Fort Lauderdale Executive Airport (FXE) determined the vehicle would not meet their needs. Fleet Services has agreed to retain the van and use it as a loaner vehicle and for larger groups touring the city, safety training, and large groups going out of town. An associated accounting transaction will be recorded to transfer the asset and pay the Airport Fund for the asset at fair market value using Fleet Funds. In addition to the purchasing the van from FXE, the Fleet Fund is estimated to incur annual expenses of approximately \$2,000 for vehicle maintenance and fuel.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$4,456 for the difference between the fair value (\$24,658) and the book value (\$20,202) to facilitate the transfer of the van.

Police

M. Appropriation of Fund Balance – Law Enforcement Trust Fund – Smart Board Interactive Panel - \$21,550

This request is to appropriate funds for the purchase of a Smart Board Interactive Panel with software by Audio Visual Innovations, Inc. in the amount of \$21,549.81. The Fort Lauderdale Police Department has established a Real Time Crime Center (RTCC) within the Department headquarters. The RTCC has become the centralized location for the real-time monitoring and operational command center to manage and support police responses to particular incidents and events occurring throughout the city. The Smart Board will be installed in the Police Chief's Conference room and will be configured to be connected to the RTCC for viewing digital content (video, images, etc.).

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$20,202 for the purchase of the Smart Board Interactive Panel. There is an associated CAM #17-0251.

Where applicable, the approval of companion agenda items listed below is contingent upon the approval of the respective companion items as part of this consolidated budget amendment.
