RESOLUTION NO. 17-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE AGREEMENTS BETWEEN MARTY KIAR, AS BROWARD COUNTY PROPERTY APPRAISER. AND THE CITY OF FORT LAUDERDALE, FLORIDA FOR REIMBURSEMENT NECESSARY ADMINISTRATIVE COSTS ASSOCIATED WITH SPECIAL AD VALOREM AND NON-AD **VALOREM** ASSESSMENT TAX ROLLS FOR PROPERTIES WITHIN THE CITY OF FORT LAUDERDALE, FLORIDA, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale ("City") has adopted several resolutions authorizing the proper City officials to execute a written agreement with Lori Parrish as Broward County Property Appraiser ("Property Appraiser") to provide for the reimbursement of necessary administrative costs incurred by the Property Appraiser in association with the creation and maintenance of special ad valorem and non-ad valorem assessment rolls for properties within the City; and

WHEREAS, agreements between the City and the Property Appraiser contain a clause that automatically terminates the agreement at the end of Lori Parrish's term of office as Property Appraiser; and

WHEREAS, Lori Parrish's term of office as Property Appraiser ended on January 3, 2017; and

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida desires to execute agreements with Marty Kiar as Property Appraiser with substantially the same terms and conditions as those approved with Lori Parrish as Property Appraiser;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the proper City officials are hereby authorized to execute agreements between Marty Kiar, as Broward County Property Appraiser and the City of Fort Lauderdale as the proper Taxing Authority for Special Ad Valorem and Non-Ad Valorem Assessments commencing with the 2017 assessment roll with substantially the same terms and conditions as those agreements previously approved with Lori Parrish as Property Appraiser.
