> Simone Mulheron - \$30,000.00, and Approval to Accept Payment from State Farm Ins. Co. in Settlement of the City's Property Damage

Subrogation Claim - \$100,000.00

Recommendation

It is recommended that the City Commission approve the settlement of the auto liability claim of Simone Mulheron in the amount of \$30,000.00, and approve the acceptance of payment from State Farm Insurance Company, on behalf of their insureds Simone and Scott Mulheron, in settlement of the City's property damage subrogation claim in the amount of \$100,000.00.

Background

The claimant, Simone Mulheron, filed an auto liability claim against the City resulting from a disputed vehicle collision on March 13, 2013. The City filed a parallel property damage subrogation claim against Simone and Scott Mulheron, as owners of the claimant vehicle, for damages to the City owned vehicle.

Through negotiations, a settlement was reached in the amount of \$30,000 paid by the City to Simone Mulheron for her claim, and subrogation recovery to the City in the amount of \$100,000 paid by State Farm Insurance Company, subject to the approval of the City Commission.

In addition, the City reached a settlement in the amount of \$20,000 with the passenger in the Mulheron's vehicle under their separate auto liability claim. The net effect is a positive impact to the City in the amount of \$50,000 after settlement of all claims from this accident.

Resource Impact

There will be a fiscal impact to the City of \$30,000 and a positive impact to the City of \$100,000. The net effect is a positive impact to the City in the amount of \$70,000 from this claim, and \$50,000 after settlement of all claims from this accident.
