TITLE: Motion to Approve Contract for Purchase of Curbside Recycling Collection

Services – Gold Medal Services of FL, LLC - \$4,487,455 (three-year total)

Recommendation

It is recommended that the City Commission approve a three-year contract, in substantially the form attached, with Gold Medal Services of FL, LLC for the purchase of curbside recycling collection services in the estimated three-year amount of \$4,487,455; and authorize the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds.

Background

The Public Works Sustainability Division provides, through contracted services, curbside collection of recyclable materials to 37,888 customers throughout the City. The current contract is set to expire on November 30, 2017.

The background of the solicitation process includes the following:

- December 23, 2016 Procurement Services Division issued Request for Proposals (RFP) 875-11864 for curbside recycling collection services.
- January 20, 2017 The RFP closed with a total of four firms submitting proposals including:
 - Gold Medal Services of FL, LLC
 - Republic Services of Florida Limited Partnership
 - Thoroughbred Waste Services, LLC
 - World Waste Recycling
- January 30, 2017 The Evaluation Committee (Committee) consisting of Nancy J. Gassman, Ph.D., Assistant Public Works Director; Julie Leonard, Deputy Director of Transportation and Mobility; and Enrique Sanchez, Deputy Director of Parks & Recreation, met with Laurie Platkin, Procurement Specialist II, to evaluate the proposals and establish initial rankings. The top three ranked firms were invited to give formal presentations to the Committee.

 February 15, 2017 – The Committee met to hear formal presentations from the short listed vendors: Gold Medal Services of FL, LLC, Republic Services of Florida Limited Partnership, and World Waste Recycling. The firms were evaluated and ranked based on the criteria shown in the table below.

The three firms were ranked as follows:

Gold Medal Services of FL, LLC – (1st Place)

World Waste Recycling – (2nd Place)

Republic Services of Florida – (3rd Place)

Gold Medal Services of FL, LLC has met all requirements of the RFP specifications and has been deemed the responsive and responsible proposer recommended for award of this contract.

The Notice of Intent to Award was posted on February 22, 2017, and as of the close of the protest period no formal bid protest had been received.

Resource Impact

There is no current fiscal year impact to the City for this item. Funds for this purchase in the amount of \$4,487,455 are contingent upon fund availability and adoption of future years' Operating Budgets.

Strategic Connections

This item is a *Press Play Fort Lauderdale Strategic Plan 2018* initiative, included within the Infrastructure Cylinder of Excellence, specifically advancing:

- Goal 2: Be a sustainable and resilient community.
- Objective 4: Reduce solid waste disposal and increase recycling.

This item advances the Fast Forward Fort Lauderdale 2035 Vision Plan: We Are Ready.
