TITLE: Motion to Approve Amendment to Contract for Fleet Maintenance and

Management Services - First Vehicle Services, Inc. - \$188,838

Recommendation

It is recommended that the City Commission approve an amendment to contract for fleet maintenance and management services with First Vehicle Services, Inc. (FVS) to increase contract value by \$188,838; and authorize the City Manager or designee to approve two, two-year renewal options, contingent upon appropriation of funds.

Background

On April 21, 2015, the City Commission approved the purchase of fleet maintenance and management services from FVS in the estimated amount of \$16,675,000 (three-year estimated cost) via CAM #15-0370.

Section 13.7 of the solicitation notes that the Agreement Targeted Operating Budget Cost will be adjusted to correspond to increases or decreases in fleet size (on a vehicle-equivalent basis specified by the City) if such changes are at more than ten percent (higher or lower) by vehicle and equipment category compared to the fleet inventory at the time the solicitation was issued.

An analysis was performed by Public Works - Fleet Services Division and First Vehicle Services on the overall fleet size effective September 1, 2016 (Exhibit 2). Fifteen vehicle categories increased by more than 10% and seven decreased by more than 10%. Since the Request for Proposals (RFP) was issued, the overall fleet size has increased by 6.22% from 1463 to 1553 vehicles. Multiple factors have contributed to an increase in overall fleet inventory especially in the following categories.

- Refuse Truck category have increased 41% due to the expansion of the bulk collection service area and the transition from dump trucks and loaders to claw trucks.
- The Fire Truck Ambulance Vehicle category increased 20% due to the retainage of apparatus that had been replaced with new vehicles to ensure adequate spares to support fire and emergency operations.

Per the contract, an adjustment may be made to accommodate FVS's increased staffing needs and operational costs related to the increased number of vehicles being maintained. Staff worked with FVS to develop an acceptable methodology to determine the additional contract expense, calculated at \$188,838 as prorated for FY 2017 (Exhibit 3).

The proposed amendment also includes the Commission-approved contract term, including renewal options that were inadvertently omitted at the time of agreement finalization.

Resource Impact

There is an anticipated fiscal impact to the City in the amount of \$188,838. Funds are available in the FY 2017 Budget in the account listed below:
