Recommendation

It is recommended that the City Commission approve Amendment One to Task Order Number 35 for Southeastern Engineering Contractors, Inc., due to unforeseen conditions discovered during construction amounting to \$29,953 and bringing the total value of the task order to \$79,828.

Background

Section 2-127 of the City Code specifies that "Change orders and task orders and amendments to change orders and task orders over a cumulative amount of twenty-five thousand dollars (\$25,000.00) shall be subject to city commission approval."

On January 8, 2013, the City Commission approved contract 623-11048 with Southeastern Engineering Contractors for construction of storm drainage infrastructure on an as needed basis with a contract cap of \$2,000,000 (CAM 12-2514). Task Order #35 was issued on Sept 8, 2016 in the amount of \$49,875 for replacement of 168 linear feet of collapsed drainage pipe and associated infrastructure due to damage and degradation in the vicinity of Northwest 22nd Street and 28th Avenue.

Upon excavation, the contractor identified additional work necessary due to unforeseen conditions during construction. The additional work included 55 linear feet of pipe, three additional structures, and the asphalt and infrastructure required for the restoration. Amendment 1 provides for the additional work needed to complete improvements to the storm drainage system being installed under Task Order Number 35.

Resource Impact

There will be a fiscal impact to the City in the amount of \$29,953 for the task order amendment. Funds for this amendment in the amount of \$29,953 are available in the FY 2017 Operating Budget in the account listed below:
