Ordinance Amending Article X, Vacation Rentals, Chapter 15 of the Code of Ordinances of the City of Fort Lauderdale

#### **Recommendation**

It is recommended that the City Commission adopt an ordinance amending Article X, Vacation Rentals, Chapter 15 of the Code of Ordinances of the City of Fort Lauderdale.

## **Background**

At the December 6, 2016 Regular Meeting, the City Commission adopted Ordinance C-16-25 to address specific issues with the existing vacation rental ordinance. During the adoption process the City Commission directed staff to explore reducing the registration fee for owner occupied vacation rental properties.

Staff performed analyses of the costs associated with the processing of application for registration of vacation rentals and the issuance of certificates of compliance. The analysis revealed no difference in the time and resources used during the initial registration and inspection of both an owner occupied vacation rental and non-owner occupied vacation rental; therefore, different fee rates could not be legally justified. However, staff did note that the registration renewal of owner-occupied vacation rentals does not require the same amount of staff resources and time as non-owner occupied vacation rentals. As such, staff proposes eliminating the onsite inspection requirement for the renewals of owner-occupied vacation rentals. The amendment to Section 15-276 will allow a sworn affidavit to be used by the property owner to verify compliance, which significantly reduces the annual registration cost and in turn the registration fees.

The proposed ordinance also adds language to Section 15-276 of the Code of Ordinances of the City of Fort Lauderdale. The new language in Section 15-276 clarifies that the existing unlawful act of giving false or misleading information applies to all applications for registration, modification, or renewal of the vacation rental.

Additionally, the proposed language in Section 15-279 enables the City Commission to adopt a resolution that will prescribe the circumstances under which the inspections required by Section 15-276 may be waived. occupied vacation rental property.
