- TITLE: Motion Approving an Application for a Temporary Beach License and Outdoor Event Agreement with Sports Endeavors, Inc. for a Volleyball Competition

Recommendation

It is recommended that the City Commission approve an application for a temporary beach license and outdoor event agreement; and authorize the City Manager to execute the agreement on behalf of the City of Fort Lauderdale with Sports Endeavors, Inc. for a volleyball competition.

Background

City staff has been working closely with the event organizer regarding event topics, such as logistics, maintenance, and security as detailed below. Amplified music was discussed and the event organizer was advised of the noise ordinance and possible concerns.

The event organizer will pay for all event costs and submit the required certificates of insurance. The agreement provides that the organizer will pay \$500 for each event use of the beach. The event organizer will secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been notified as appropriate regarding this event. Event details are included in the event application as attached.

The event organizer is required to keep 4 volleyball courts open so there is no disruption in the opportunity for the public to play volleyball on the beach during the event date.

Authorization for the execution of event agreements is contingent upon the City Attorney's Office receiving and approving a validly executed agreement.
