Recommendation

It is recommended that the City Commission approve event agreements with related road closings with Tarpon Bend Food & Tackle-Riverwalk, LTD; Faber Brothers, LLC; Downtown Himmarshee Village Association, Inc.; and The Multiple Myeloma Research Foundation, Inc. It is also recommended that the City Commission authorize execution of the agreements by the City Manager.

Background

Where applicable, the City Commission authorizes amplified music for the events listed below.
