TITLE: Motion to Approve Purchase of Fire Hydrants – HD Supply Waterworks,
LTD - \$225,000

Recommendation

It is recommended that the City Commission approve the purchase of fire hydrants through the Southeast Florida Governmental Cooperative Purchasing Group (Co-op) Contract/Bid No. F-4493-16-RL (Contract) from HD Supply Waterworks, LTD in the aggregate amount of \$225,000; and authorize the City Manager to approve two, one-year renewal options coterminous with the Contract.

Background

This purchase is being made through a Co-op contract with the City of Hollywood acting as lead agency. Thirteen other municipalities are currently utilizing this Contract. The commodities specified in the bid were determined by participating agency members consisting of products used by the majority of the Co-op.

The awarded vendor will supply fire hydrants for the Public Works Department. HD Supply Waterworks, LTD is the lowest responsive and responsible bidder awarded for items in accordance with unit prices identified in Exhibit 1.

Pursuant to Section 2-198, Code of Ordinances of the City of Fort Lauderdale, Florida, “[t]he city manager or the city manager’s designee shall have the authority to join with other units of government in cooperative purchasing plans when the best interest of the city would be served thereby.”

Resource Impact

There will be a fiscal impact to the City in the estimated amount of \$75,000 in FY 2017. Future expenditures are contingent upon approval and appropriation of the annual budget.
